STREAMLINED RENEWALS FOR RADIO PROGRAMMING UNDERTAKING LICENCES DUE TO EXPIRE IN 2005

DEADLINE FOR SUBMISSION OF INTERVENTIONS/COMMENTS

24 May 2005

The Commission announces that it has received abridged licence renewal applications for radio programming undertakings whose licences are due to expire on 31 August 2005, as listed in this public notice. These applications were received and are being processed pursuant to the revised procedures announced in Broadcasting Circular CRTC 2002-448 entitled “The CRTC Streamlines Radio Renewals Process”.

The Commission intends to renew these broadcasting licences for a full seven year term, subject to any interventions. The conditions specified in the following applicable Public Notices as well as the conditions contained in the current licences would apply:

- ◆ Public Notice CRTC 1999-137 – Commercial radio stations
- ◆ Public Notice CRTC 2000-156 – Campus radio stations
- ◆ Public Notice CRTC 2000-157 – Community radio stations
- ◆ Public Notice CRTC 2001-70 – Native radio stations
