**Preamble (for items 1 to 19)**

On 12 April 2005, the Commission issued Broadcasting Public Notice CRTC 2005-30 calling for applications for broadcasting licences to provide radio programming services for Grande Prairie, Alberta.

On 22 July 2005, the Commission issued Broadcasting Public Notice CRTC 2005-70 calling for applications for broadcasting licences to provide radio programming services for Fort McMurray, Alberta.

In response to these calls, the Commission has received a number of applications for licences to serve these markets.
