PREAMBLE

For items 1 to 24

On 18 November 2005, the Commission issued Broadcasting Public Notice CRTC 2005-103 calling for applications for broadcasting licences to provide radio programming services for Medicine Hat, Alberta.

On 29 March 2006, the Commission issued Broadcasting Public Notice CRTC 2006-37 calling for applications for broadcasting licences to provide radio programming services for Regina, Saskatchewan.

On 29 March 2006, the Commission issued Broadcasting Public Notice CRTC 2006-36 calling for applications for broadcasting licences to provide radio programming services for Saskatoon, Saskatchewan.

In response to these calls, the Commission has received a number of applications for licences to serve these markets.

Some of these applications are technically mutually exclusive. These applications are:

For Medicine Hat:

- Items 4, 5 and 9 are technically mutually exclusive proposing the use of frequency 102.1 MHz.
- Items 1, 6, and 8 are technically mutually exclusive proposing the use of frequency 105.3 MHz.

These applications along with items 2, 3 and 7 will be treated as competitive radio applications for Medicine Hat.

For Regina:

- Items 12 and 13 are technically mutually exclusive proposing the use of frequency 96.1 MHz.

These applications along with items 10, 11, 14 and 15 will be treated as competitive radio applications for Regina.

For Saskatoon:

- Items 23 and 24 are technically mutually exclusive proposing the use of frequency 106.7 MHz.

These applications along with items 16, 17, 18, 19, 20, 21 and 22 will be treated as competitive radio applications for Saskatoon.

Item 25

The Commission intends to examine the renewal of the broadcasting licenses for Aboriginal Voices Radio Inc. (AVR) for their radio undertakings at Vancouver, Calgary, Toronto and Ottawa. The Commission intends to discuss various issues with the licensee at the hearing.
