## Chez moi - Category 2 specialty service

In this decision, the Commission approves an application for a broadcasting licence to operate a new Category 2 specialty programming undertaking.

#### The application

- 1. The Commission received an application by Astral Broadcasting Group Inc. (Astral Group) for a broadcasting licence to operate a national, French-language Category 2<sup>1</sup> specialty programming undertaking to be known as Chez moi.
- 2. The applicant proposed to offer a service that would be devoted to lifestyle and the home: food, interior design, do-it-yourself, consumer, gardening, landscaping, and environmental shows. Astral Group proposed to air news magazines, reports, documentaries, reality television shows and, on occasion, lifestyle dramas. All of the programming would be drawn from the following categories, as set out in Schedule I to the *Specialty Services Regulations*, 1990: 2(a) Analysis and interpretation; 2(b) Longform documentary; 3 Reporting and actualities; 5(b) Informal education/Recreation and leisure; 7(a) Ongoing drama series; 7(b) Ongoing comedy series (sitcoms); 7(c) Specials, mini-series or made-for-TV feature films; 10 Game shows; 11 General entertainment and human interest; 12 Interstitials; 13 Public service announcements; and 14 Infomercials, promotional and corporate videos.
- 3. The Commission did not receive any interventions in connection with this application.

## Commission's analysis and determination

- 4. The Commission is satisfied that the application is in conformity with all applicable terms and conditions announced in *Introductory statement Licensing of new digital pay and specialty services Corrected Appendix 2*, Public Notice CRTC 2000-171-1, 6 March 2001 (Public Notice 2000-171-1). Accordingly, the Commission **approves** the application by Astral Broadcasting Group Inc. for a broadcasting licence to operate the national, French-language, Category 2 specialty programming undertaking, Chez moi.
- 5. The licence will expire 31 August 2012, and will be subject to the **conditions** set out in Public Notice 2000-171-1, as well as to the **conditions** set out in the appendix to this decision.

#### Issuance of the licence

- 6. A licence will be issued once the applicant has satisfied the Commission, with supporting documentation, that the following requirements have been met:
  - the applicant has entered into a distribution agreement with at least one licensed distributor; and
  - the applicant has informed the Commission in writing that it is prepared to commence operations. The undertaking must be operational at the earliest possible date and in any event no later than 36 months from the date of this decision, unless a request for an extension of time is approved by the Commission before 19 October 2008. In order to ensure that such a request is processed in a timely manner, it should be submitted at least 60 days before that date.

## **Appendix to Broadcasting Decision CRTC 2005-503**

#### **Conditions of licence**

- 1. The licence will be subject to the conditions set out in *Introductory statement Licensing of new digital pay and specialty services Corrected Appendix 2*, Public Notice CRTC 2000-171-1, 6 March 2001.
- 2. The licensee shall provide a national, French-language Category 2 specialty programming undertaking devoted to lifestyle and the home: food, interior design, do-it-yourself, consumer, gardening, landscaping, and environmental shows. The programming shall include news magazines, reports, documentaries, reality television shows and lifestyle dramas.
- 3. The programming shall be drawn exclusively from the following categories, as set out in Schedule I to the *Specialty Services Regulations*, 1990, as amended from time to time:
  - 2 (a) Analysis and interpretation
    - (b) Long-form documentary
  - 3 Reporting and actualities
  - 5 (b) Informal education/Recreation and leisure
  - 7 (a) Ongoing drama series
    - (b) Ongoing comedy series (sitcoms)
    - (c) Specials, mini-series or made-for-TV feature films
  - 10 Game shows
  - 11 General entertainment and human interest
  - 12 Interstitials
  - 13 Public service announcements
  - 14 Infomercials, promotional and corporate videos
- 4. No more than 15% of all programming broadcast during each broadcast week shall be drawn from category 7.

For the purposes of the conditions of this licence, including condition of licence no. 1, *broadcast day* refers to the 24-hour period beginning each day at 4 a.m., or any other period approved by the Commission.
