Subject: *Review of price cap framework*, Telecom Public Notice CRTC 2006-5 ("PN 2006-5") –Interrogatories to Parties

- 1. In accordance with the procedures set out by the Commission in PN 2006-5, please find attached interrogatories from TELUS Communications Company addressed to the Consumer Groups, CAC Manitoba and MTS Allstream.
- 2. In TELUS' view, portions of the evidence submitted by the City of Calgary are outside the scope of the proceeding established by the Commission. Specifically, in sections 5 through 9 of its evidence, the City of Calgary addresses the return on equity on regulated services earned by the ILECs, which is clearly outside the scope of the proceeding set out in PN 2006-5.
- 3. TELUS reserves the right to address interrogatories to the City of Calgary on its evidence if the Commission changes the scope of the proceeding to include return on equity issues.

Consumer Groups(TELUS)8Aug06-1

Economies of scope arise when a multi-product firm's average total costs decline as the number of different products and/or services produced by the firm increases.

- a) Please provide the source of this definition.
- b) In this context of multiple service offerings, please define 'average total costs' as used in the above quote and provide a formula to measure this concept.

In reference to paragraph 50 of Dr Roycroft's evidence, please provide all data related to the labour cost study performed by Dr. Roycroft for the U.S. Regional Bell Operating Companies (RBOCs) for the years from 1995 to 2004.

Dr Roycroft states at paragraph 55 of his evidence that

Total factor productivity may be calculated using econometric techniques, which can be used to estimate the marginal cost of production.

In the context of a telecommunications carriers that has multiple outputs, which are not perfect substitutes or perfect complements, and multiple inputs, which are also not perfect substitutes or perfect complements, provide the equations establishing how total factor productivity determines the marginal cost of production for an individual output produced by the telecommunications carrier.
