Re: Public Notice 2004-1 - Review and disposition of deferral accounts for the second price cap period - Application for Costs

CAD – Canadian Association of the Deaf, in accordance with Rule 44 of the CRTC Telecommunications Rules of Procedure, applies for costs with respect to Public Notice 2004-1. CAD submits that its participation in this proceeding meets all of the requirements set out in Rule 44.

1. They represent a class of subscribers who receive a benefit or suffer a detriment as a result of this proceeding.

CAD represents the interests of Canadians who are Deaf. This group of subscribers has an important stake in the outcome of the proceeding. Deaf people face discrimination in their telecommunications use. In earlier proceedings, Access to pay telephone service, Telecom Public Notice CRTC 2002-6 CAD participated fully and submitted that the deferral accounts pay to remedy the payphone discrimination. The Commission agreed and so ordered.

We submit that CAD's participation in this hearing has expanded upon the understanding of the public interest in telecommunications regulation relating to other aspects than pay telephone access.

2. They have participated in a responsible manner in this proceeding.

CAD actively participated in this proceeding making detailed submissions and comments and attempting to elicit relevant information through interrogatories.

3. They have contributed to the Commission's better understanding of the issues raised herein.

CAD submits that its participation has assisted the Commission in understanding the telecommunication needs of the Deaf and how they are currently not met and how they might be better addressed by wise use of the deferral account funds.

CAD is applying for legal costs of \$13,904.65.

CAD takes no position on the appropriate respondents to this application.


