FILING ARTICLES OF AMENDMENT Under The Corporations Act of Manitoba

If a Manitoba corporation wants to make significant changes to its incorporating documents it must file ARTICLES OF AMENDMENT, by following these steps:

<u>STEP 1: RESERVING THE NAME</u> (only if the corporation is changing its name)

Request for Name Reservation

In addition to the traditional paper application that is still available, a Request for Name Reservation can be filed online at https://direct.gov.mb.ca/coohtml/html/internet/en/coo.html.

If your name is **reserved**, you will have 90 days to file the Articles of Amendment forms by following Step 2 below. If your name is **rejected**, you must choose a new name and do Step 1 over again (including fee).
