Re: Amendments to Schedules A and C of Quarry Minerals Regulation MR 65/92 Effective Date January 30, 2006

Mines Branch services are regularly being improved to meet the needs of our clients, stakeholders and aggregate operators. While meeting their requirements and remaining competitive in the industrial mineral sector, it was necessary for the department to increase some royalty rates and service fees. The increases in revenue will offset the costs associated with upgrading our data management systems, including development of a web interface to enhance mineral title and disposition administration. Upon completion of the enhancements, clients will benefit from improved client services and have the ability to transact business through e-Business solutions.

The fees for service have been increased by the Consumer Price Index. Royalty rates have been raised based upon the Construction Price Index. At this time not all fees and royalties have been increased. In fact many royalties remain unchanged since 1992 when the new Mines and Minerals Act and Regulations were introduced. The attached Schedules A and C indicate the changes to the rates, fees and effective date. A general review of fees and royalty rates will be conducted annually and adjusted where appropriate in accordance with Index changes.

*A conversion factor of 1.78 tonnes per cubic metre shall be used where quarry mineral production is calculated in cubic metres.

**Calculation of rehabilitation levy

Every operator of an aggregate quarry shall remit to the recorder a rehabilitation levy equal to the product of the number of tonnes of aggregate quarry mineral produced multiplied by \$0.10.
