

## Delegation and Designation

Pursuant to subsection 9(1) of the *Canada Border Services Agency Act*<sup>1</sup>, I hereby delegate any power, duty, or function

a) that I am authorized to exercise or perform under the *Immigration and Refugee Protection Act*<sup>2</sup> and that is set out in the attached instrument to the Executive Vice-president and any Vice-president of the Canada Border Services Agency or in his or her absence, the person carrying out his or her duties and functions; and

b) described in Column 3 of an item of the instrument in relation to a provision of the *Immigration and Refugee Protection Act* specified in column 2 of the item to each person whose title is specified in Column 4 of the item or, in his or her absence, the person carrying out his or her duties and functions.

Pursuant to subsection 9(3) of the *Canada Border Services Agency Act*, I hereby designate as officers

a) to carry out any purpose of any provision of the *Immigration and Refugee Protection Act* set out in the attached instrument, the Executive Vice-president and any Vice-president of the Canada Border Services Agency or in his or her absence, the person carrying out his or her duties and functions; and

b) to carry out the powers and duties specified in column 3 of an item of the instrument in relation to a provision set out in column 2 of the item, any officer holding a position set out in column 4 of that item or, in his or her absence, the person carrying out his or her duties and functions.
