### Introduction

### **Accessible and Affordable Post-secondary Education**

Manitoba Student Aid is committed to the principles of accessible and affordable post-secondary education. Manitoba Student Aid is also committed to ensuring that students in our province have the opportunity to develop their individual educational potential and prepare themselves for emerging opportunities in Manitoba, as well as compete in a rapidly growing, knowledge-intensive and global society. Manitoba Student Aid reduces the financial barriers that prevent students from attending post-secondary education by providing loans, grants, bursaries, scholarships and other awards. Student financial assistance is also provided to reduce loan debt and to assist students with repayment.

The Manitoba Student Aid Program provides financial assistance which is supplementary to student and family resources and is awarded through an assessment of a student's financial needs. The cost of a post-secondary education is a shared responsibility among students, their parents, spouses and the government.

Program information in this report presents financial details of the 2004/2005 program year (August 1 to July 31).

### **Background**

The Manitoba Student Aid Program operates within the Department of Advanced Education and Training. In addition to identifying broad educational and skills development goals, the department is responsible for the overall legislative and regulatory structure governing the post-secondary education and training system.

The mission of Manitoba Advanced Education and Training is to provide access to relevant education and training that is of high quality, affordable, accessible and responsive to labour market trends.

To carry out this mission, the department is committed to five primary goals:

- · Improve success rates in all programs and institutions
- Expand the range of people served
- Better integrate and support knowledge and skills development within economic and social priorities
- Build the capacity of institutions and the community to support learning
- Build partnerships within and across sectors

Prior to August 1, 2001, Manitoba student loans were financed and administered by financial institutions under either risk-shared or guaranteed loan arrangements. Nationally, student loan financing changed as a result of the federal government's August 2000 move to direct financing of Canada student loans. Effective August 1, 2001, Manitoba began to direct-finance Manitoba student loans and established the Manitoba Student Loan Service Bureau. In order to improve client services by offering students one point of contact for all their Manitoba student loan needs — from application through to repayment — the Service Bureau was integrated into Manitoba Student Aid. effective December 2003.

The authority of the Manitoba Student Aid Program is provided through the Manitoba Student Aid Act (enacted July 2001) and its attendant Regulations. This Act legislatively establishes the Manitoba Bursary and promotes the key principles of accessible and affordable post-secondary education for Manitoba students.

### Mandate of the Manitoba Student Aid Program

The mandate of Manitoba Student Aid is to improve the affordability and accessibility of post-secondary education by providing student loans and other assistance to eligible Manitobans experiencing financial barriers.

Manitoba Student Aid administers the Canada Student Loans Program and the Manitoba Student Aid Program. Assistance is based on an assessment of financial need which compares students' allowable education and living costs with their available resources. Manitoba Student Aid is also responsible for the designation of educational institutions and programs for Student Aid purposes.

Manitoba Student Aid provides financial co-ordination and support for a number of programs including the Manitoba Scholarship and Bursary Initiative, the Manitoba Bursary, the Canada Millennium Scholarship Bursary, Manitoba Study Assistance, ACCESS Bursaries, Prince of Wales/Princess Anne Awards, the Medical Student/Resident Financial Assistance Program, Aboriginal Education Awards, Youth Transition Bursary and others.

### **Program Objectives**

The key objectives of the Manitoba Student Aid Program are:

- Increase post-secondary opportunities for Manitobans by providing supplemental financial assistance to those students whose finances limit their educational choices and who might otherwise be unable to obtain a post-secondary education
- Administer the National Designation Framework and ensure that educational institutions and programs meet designation criteria for Student Aid purposes
- Increase public awareness of programs and services provided by Manitoba Student Aid to students, institutions and the general public
- Provide effective and efficient student loan administration and debt management services for Manitoba post-secondary students
- Manage grant funding to Churchill Northern Studies Centre and Aboriginal Languages of Manitoba Inc.
- Evaluate programs and services



### **Manitoba Student Aid Unit Responsibilities**

#### **Operations Unit**

#### **Application Processing**

- · Accepts applications for student aid funding
- · Determines eligibility for loan, grant and bursary programs and notifies students of awards
- Ensures the assessment of student applications on a timely basis
- Audits applications and processes to ensure compliance with governing legislation, policies and procedures

#### **Loan Services**

- Administers the disbursement, maintenance and repayment of direct-financed loans
- Provides repayment and debt management counseling to students
- Administers debt management programs such as Interest Relief, Revision of Terms and Debt Reduction in Repayment
- Administers the line of credit account with Credit Union Central of Manitoba
- · Administers the reconciliation of the direct-financed loan portfolios
- Ensures all financial transactions are processed on a timely basis

#### **Student Services Unit**

- · Provides responses to telephone and in-person inquiries from students and the general public
- Provides Student Advisor services to students who are identified as being at risk or in crisis, either financially or academically
- Liaises with administrators and staff of educational institutions to ensure they are aware of existing and new policies, procedures and programs
- · Liaises with other stakeholders to coordinate funding for mutual clients
- Promotes awareness of Manitoba Student Aid and encourages early planning for post-secondary education through presentations to students, parents, school counsellors and community groups
- Administers the Canada Study Grant for Students with Permanent Disabilities and the Exceptional Review Committee processes

#### **Policy and Planning Unit**

- Proposes strategic policy direction for Manitoba Student Aid
- Develops broad policy, research and program analysis, evaluation, interpretation and options to be used to support Manitoba Student Aid
- Facilitates and supports management decision making through planning, program development, and analysis
  of management information as it relates to all business of Manitoba Student Aid
- Performs ongoing statistical analysis, project management and support

#### **Information Systems Unit**

- Leads the branch in Information Systems planning, design and development including interfaces with Human Resources and Skills Development Canada, educational institutions and service providers
- Designs and develops Web applications (i.e. online student loan application and student specific information such as My Student Aid Online)
- Analyzes core business processes and information systems
- Provides consultative services regarding process and systems issues and desktop computers
- Liaises with the Help Desk, Systems and Technology Services , Project Management Office, and Manitoba Information and Communication Technologies

#### **Finance and Administration Unit**

- Manages the estimates and cash flow processes for the Branch
- Administers all investment, credit, asset and liability accounts with the Department of Finance
- Manages the reconciliation of the direct-financed loan portfolios
- Administers other provincial student funding programs including the Youth Transition Bursary, Manitoba Scholarship and Bursary Initiative, Aboriginal Education Awards and tuition rebates
- Manages grant funding to the Churchill Northern Studies Centre and Aboriginal Languages of Manitoba Inc.

#### **Aboriginal Liaison Unit**

- Maintains links with Aboriginal stakeholders
- Increases Aboriginal participation in post-secondary education
- Liaises with the ACCESS programs

#### **Private Vocational Institutions (PVI) & Designation Unit**

- Administers the Private Vocational Institutions Act and its regulations
- Annually registers PVIs and their instructional programs
- Offers limited consumer protection for those who access registered PVIs
- Maintains and annually reports on the Training Completion Fund, which allows students to complete their educational programs in the event of school closures
- Ensures that all applicable post-secondary institutions and programs are fairly assessed for Canada and Manitoba student loan designation
- Provides a provincial manager for maintaining the Master Designation List and administers the Pan-Canadian Designation Framework
- Involved in compliance issues relating to the Memoranda of Understanding which are signed with all designated institutions
- Monitors risk to the Student Aid portfolio by examining student repayment rates at designated institutions

### 2004/2005 Program Year

#### **Enhancements**

**Graduate Scholarships:** This scholarship fund, the first of its kind in Manitoba, supports research-based graduate studies that will help attract and retain the highest quality students from within and outside Manitoba. For the 2004/2005 fiscal year, \$352.5 was set aside to provide 18 Masters and 11 Doctoral awards.

**ACCESS Bursaries:** For 2004/2005 the ACCESS Bursary budget was increased by \$284.3. The increase provided an additional 25 funded spots in the Winnipeg Education Centre's Bachelor of Social Work Program.

**Implementation of Designation Program:** Department staff completed a Memorandum of Understanding with designated public and private post-secondary institutions in Manitoba. These Memoranda clearly articulate default prevention plans and identify performance indicators and activities that all institutions must implement to increase student loan repayment rates.

- Managed an existing loan portfolio of approximately \$79 million involving approximately 30,000 students (direct-financed Manitoba Student Aid loans and lender-financed loans)
- Managed the annual \$1.4 million Interest Relief and Debt Reduction programs
- Managed the loans administration for new and existing loans, including annual expenditures of approximately \$4.8 million for Provision for Loss, Interest Subsidy and previous Risk Premiums with the national banks
- Disbursed approximately \$21.6 million in new loans to 7,721 Manitoba student loan recipients
- Applied loan remission to 4,612 student loan accounts; 2,947 Canada Millennium Scholarship Bursaries and 1,665 Manitoba Bursaries
- Monitored approximately 3,200 students in repayment of their direct-financed Manitoba student loans to ensure compliance with repayment obligations

#### Medical Student/Resident Financial Assistant Program:

• Monitored 488 grants of approximately \$8.9 million to ensure program compliance

#### **Student Support Services:**

- Responded to approximately 42,430 requests for information and assistance over the telephone
- Provided services to an additional 25,467 in-person requests

#### **Registrations and Designations:**

- 37 private vocational institutions were registered
- 26 institutions had programs of study designated for the Canada/Manitoba student loan programs

## Highlights of the Manitoba Student Aid Program for 2004/2005

Strategies to Improve Student Services, Manage Debt Levels and Reduce Student Loan Default Rates

#### The Manitoba Bursary

The Manitoba Bursary remains the cornerstone of a strategy to manage student loan debt and reduce default rates. The other components of the strategy include student advisor services, repayment counsellors and a more stringent institution and program designation policy.

In 2004/2005, 1,665 students received a Manitoba Bursary with an average award of \$2,852 that was used to reduce their Manitoba Student Loan debt. Together with the Canada Millennium Scholarship Bursary (CMSB), the Manitoba Bursary helped bring student loan debt down to approximately \$6,000 per year for most students.

#### **Service Enhancements**

Every Tuesday, from June through September, Student Aid's Winnipeg office is open until 6 pm to provide extended hours of service to students (in person and by phone) during the peak application period.

Telephone call volumes increase significantly during peak periods. In order to ensure that callers do not receive a busy signal, all overflow calls are routed to a message centre where callers can leave a message with an operator. Student Aid staff return the calls with 48 hours.

#### **Student Advisor Services**

Student Advisors (four in Winnipeg and one in Brandon) counsel post-secondary students who may have student aid concerns resulting from financial, academic or personal issues. The Advisors also provide program information to students and the general public, support administrators of post-secondary institutions, and work with other stakeholders and service providers to assist post-secondary clients.

Student Advisors provide expanded outreach into the community through increased program awareness and information sessions with high school students and parents, as well as increased participation in provincial educational and career symposia.



**Helping Students** 

Manitoba Student Aid's Aboriginal Liaison Consultant works specifically within the Aboriginal community to promote post- secondary education that addresses Aboriginal students' needs.

#### **Repayment Counsellors**

Repayment Counsellors are an integral part of the Loan Services Unit, as they help reduce Manitoba Student Loan delinquencies. Their role is to contact and obtain the borrower's cooperation in repaying their outstanding student loan(s). Repayment Counsellors analyze a borrower's financial status, and provide counselling and advice on various repayment options including debt management programs available to those experiencing financial hardship while in repayment of their Manitoba Student Loan(s).

#### **Institution and Program Designation Policy**

Manitoba Student Aid is responsible for designating approximately 800 educational institutions in Manitoba, across Canada and internationally.

A Pan-Canadian Designation Framework was developed to strengthen consumer protection for student loan recipients, to ensure taxpayer protection with respect to student loan funds, and to support accountability and informed choice. Institutions are required to meet the Framework's common elements which include common eligibility criteria for programs, accountability standards for student loan administration, requirements to improve student success, and financial risk monitoring. The framework was implemented in the 2004/2005 program year.

#### **Canada Millennium Scholarship Bursary (CMSB)**

2004/2005 marked the sixth year of Manitoba Student Aid's CMSB delivery. Manitoba's annual allocation of approximately \$10.6 million was used primarily to reduce Manitoba Student Loan debt. In 2004/2005, approximately 2,900 Manitoba students received this loan remission (ranging from \$1,000 to \$4,500 per student).

## **Enhancements to Internet Application and Web Site for Manitoba Student Aid**

In 2004/2005, Manitoba Student Aid continued to improve its interactive online application and web site to make them more user-friendly for students. Through MySAO (My Student Aid Online), students can now apply for financial aid, check on the status of their application, and view their Manitoba Student Loan balance for loans that were issued after 2001. Students can also view a list of required documentation and are able to print forms required by Manitoba Student Aid. The most recent MySAO enhancement – 'Change My Information' – enables students to submit requests to change some of their application information, including contact information, next of kin information, course load and student number. During 2004/2005, MySAO was profiled by Service Manitoba as Best Practices in Electronic Service Delivery.

In 2004/2005, approximately 71% of applications were received via the Internet. This was a 9% increase over the previous year.

#### **Extended Interest-Free Period**

Manitoba Student Loans are interest-free while students are in school full time. Repayment is not required until six months after the program ends. However, students who continue to live in Manitoba after their program completion are granted an additional six months of interest-free and payment-free status.

#### **Aboriginal Education Awards**

In 2004/2005, 120 Aboriginal students shared a total of \$312,000 in Aboriginal Education Awards. Contributions from the partners - the Business Council of Manitoba, the Government of Canada, and the Province of Manitoba – have increased to \$150,000 per year, for a total of \$450,000 per year based on matching funds.

#### Medical Student/Resident Financial Assistance Program (MSRFAP)

In 2004/2005, 139 students received a total of \$2,535,000 in conditional grants. These awards are non-repayable provided the student works in Manitoba for one year for each grant awarded upon completion of their program.

#### **Youth Transition Program**

In 2004/2005, 11 high school graduates received a total of \$33,000 in bursaries in exchange for up to 12 months of paid work experience in the Manitoba Government. Graduates received a \$3,000 bursary when they completed their work experience and enrolled in a post-secondary institution.

## **Manitoba Student Aid Eligibility and Programs**

### **Eligibility for Assistance**

Manitoba Student Aid uses federal program criteria to determine the applicant's eligibility for student loans.

To qualify for student loans, the student must:

- Be a Canadian citizen, Permanent Resident (landed immigrant) or Protected Person, as defined under Canadian immigration legislation
- Be a resident of Manitoba according to program criteria
- Study at an institution that is designated for Manitoba Student Aid purposes
- Study in a designated program that is at least 12 weeks long, within a period of 15 consecutive weeks, and leads to a certificate, diploma, or degree
- Maintain satisfactory progress and attendance
- Not be in default of previous federal or provincial student loans or have a poor credit history
- · Be in financial need

#### **Course-load requirements:**

- Full-time students need to maintain the minimum required course load for the entire academic year, which is at least 60% of a full course load (40% of a full course load for students with permanent disabilities). The required course load for students in a private vocational institution is 100% of the program.
- Part-time students need to maintain between 20% and 59% of a full course load for the entire academic year (20% to 39% for students with permanent disabilities).

### **Repayable Assistance**

**Canada Student Loans (CSL)** provides 60% of a student's assessed need, up to a maximum of \$165 per week of study (\$5,610 for a 34-week university program). The loan is interest free while the student is in full-time studies and becomes repayable six months after the program ends. Interest on the CSL begins when the student has completed their studies.

Manitoba Student Loans (MSL) provides 40% of a student's assessed need, up to a maximum of \$110 per week of study (\$3,740 for a 34-week university program). These loans are also interest free while the student is in full-time studies. Repayment is not required until six months after the program ends. Unlike CSLs, Manitoba Student Loans are interest free during this six-month period. Students who continue to live in Manitoba after they have completed their studies are granted an additional six months of interest-free and payment-free status.

## Non-repayable Assistance

To be eligible for non-repayable assistance students must be in full-time studies, be eligible for Canada Student Loan/Manitoba Student Loan and have a financial need assessed by Manitoba Student Aid. This assistance includes ACCESS Bursary, Manitoba Study Assistance, Prince of Wales/Princess Anne Awards and Canada Study Grants.

**ACCESS Bursary** provides a provincial bursary to full-time students who are funded through the ACCESS Program. Eligible students receive 60% of their assessed need in CSL, up to a maximum of \$165 per week of study, and the balance of their assessed financial need in ACCESS bursary.





Figure 7: Number of ACCESS Bursary Students 1995/1996 to 2004/2005







Figure 8: Distribution of ACCESS Bursary by Demographic Group 2004/2005

**Manitoba Study Assistance (MSA)** provides up to \$40 per week of study to full-time students whose assessed financial needs are higher than the maximum Canada and Manitoba Student Loan limits and who have exhausted all other support sources. For a 34-week program of study, the maximum assistance is \$1,360.

#### **Canada Study Grants for Full-time Students**

- Students with Permanent Disabilities (CSG Disability) provides up to \$8,000 annually to students to cover exceptional education-related costs associated with permanent disabilities, including deafness, blindness, physical disabilities or learning disabilities.
- High-need Students with Permanent Disabilities (CSG High-need w/Disability) provides up to \$2,000 annually to students with permanent disabilities with assessed need over the available maximum assistance. It is available to cover the costs of accommodation, tuition, books and other education-related expenses.
- Students with Dependants (CSG FT Dependants) provides up to \$40 per week of study for students with one or two dependants and up to \$60 per week of study for students with three or more dependants. It is available to students whose financial needs exceed the Canada Student Loan/Manitoba Student Loan maximum (\$275/week).
- Female Doctoral Students (CSG Women in Ph.D) provides up to \$3,000 annually for a maximum of three years to eligible female students with assessed needs, studying at the doctoral (Ph.D) level in selected non-traditional fields or in fields where women are under-represented.

### **Assistance for Part-time Students**

**Canada Student Loans for Part-time Students (CSL PT)** provides up to \$4,000 in loans to students taking between 20% to 59% of a full course load (20% to 39% of a full course load for students with a permanent disability) in a program leading to a certificate, diploma or degree. The first interest payment is due 30 days after it is advanced by the lender. Monthly payments on the interest and principal are required six months after the program ends.

#### **Canada Study Grants for Part-time Students:**

- Part-time Students with Permanent Disabilities (CSG Disability PT) provides up to \$8,000
  annually to part-time students to cover exceptional education-related costs associated with permanent
  disabilities, including deafness, blindness, physical disabilities or learning disabilities.
- High-need Part-time Students with Permanent Disabilities (CSG High-need w/Disability PT) provides up to \$2,000 per loan year to high-need students with permanent disabilities to help cover the costs of tuition, accommodation, books and other education-related expenses. To be eliqible, the student's assessed allowable costs must be greater than \$4,000 per year.
- **High-need Part-time Students (CSG PT)** provides up to \$1,200 per loan year to eligible students who meet income limits and have a valid reason for going to school part time rather than full time. This would include students with cash flow problems and who are unable to pay immediate educational expenses.
- Part-time Students with Dependants (CSG PT Dependants) provides up to \$1,920 per loan year to students with dependants whose financial needs exceed the maximum High-need Grant for Part-time Students and maximum Part-time Canada Student Loan.

Manitoba Bursary (MB) – This \$6.26 million provincial loan remission program is designed to increase the accessibility and affordability of post-secondary education for Manitoba students. Students are automatically considered for this bursary when they submit their application for Canada and Manitoba student loans. This bursary assists students studying in Canada, especially those in the first year of studies and those in graduate programs who are not eligible for Canada Millennium Scholarship Bursaries. 1,665 students received this bursary in 2004/2005 with awards averaging \$2,852. The Manitoba Bursary is used to pay down Manitoba student loan debts. Together with the Canada Millennium Scholarship Bursary, the Manitoba Bursary helped reduce annual student loan debt levels to approximately \$6,000 for 2004/2005.



Providing Student Aid Information

Canada Millennium Scholarship Bursary (CMSB) — Manitoba Student Aid administers Canada Millennium Scholarship Bursaries to Manitoba's post-secondary students on behalf of the Canada Millennium Scholarship Foundation (CMSF). The federal government established the CMSF in 1998 in response to rising student debt and loan default rates. Manitoba's share of the \$2.5 billion scholarship endowment, based on population, is currently \$10.6 million each year. Students who apply for Canada and Manitoba student loans are automatically considered for this loan remission program. These bursaries are granted to Manitoba Student Aid recipients who have the highest assessed financial need, who have successfully completed at least one year of previous post-secondary studies and who are studying at the undergraduate level in Canada. In 2004/2005, approximately 2,900 Manitoba students were awarded these bursaries. CMS Bursaries ranged from \$1,000 to \$4,500 per student and were used to pay down the students' loan debts.

Figure 20: Distribution of CMSB (\$) 2004/2005



Distribution of CMSB – 61% of CMSB was provided to students studying at Manitoba universities. 80% of CMSB was awarded to students studying at Manitoba institutions.

Distribution of MB – 31% of Manitoba Bursary was provided to students studying at Manitoba universities. 32% of Manitoba Bursary was provided to students studying at Manitoba private institutions. 16% of Manitoba Bursary was provided to students studying at Manitoba community colleges.

The difference in the distributions for the CMSB and the Manitoba Bursary is due to the different groups who are eligible for the bursaries. The CMSB is provided to students who have completed one year of post-secondary studies and are in an undergraduate program. A large portion of the Manitoba Bursary is provided to first-year and graduate students.

**Interest Relief (IR)** – This debt management tool is intended to provide short-term relief to borrowers who are facing temporary financial difficulties in repaying their Canada and Manitoba student loans. Under this program payments are suspended and the federal and Manitoba Governments cover the student loan interest costs. Students apply in 6-month terms for up to 30 months of IR at any time during the life of their loan. Extended IR may be approved for up to an additional 24 months if it is within 5 years of when they last attended school full time.

**Debt Reduction in Repayment (DRR)** – This debt management tool provides assistance to borrowers who have exhausted Interest Relief and who continue to experience exceptional long-term financial difficulty paying back their student loans. Once all eligible IR has been exhausted, and borrowers are still unable to service their loans, they may apply to have their Manitoba Student Loan principal reduced by 50% of their loan balance up to \$6,667.

#### **Grants and Other Assistance**

Manitoba Scholarship and Bursary Initiative (MSBI) – This program was introduced by the Province in 1997/1998 with a \$1 million budget. The budget was increased to \$5 million per year in 1998/1999 and has remained constant. The MSBI provides one dollar in matching funds for each dollar in private donations made to Manitoba's seven public universities and colleges and the University of Manitoba Students' Union. The \$5 million is allocated according to a formula based on enrollment. Grants under this initiative significantly enhance the bursaries and scholarships that public post-secondary institutions are able to provide to their students.

**Tuition Rebate Grants** – For 2004-2005, Manitoba's public colleges and universities were provided with \$13 million in additional funding to reimburse the public post-secondary institutions for providing students with a tuition rebate of 10%, while maintaining tuition fees at the 1999-2000 tuition fee levels.

**Medical Student/Resident Financial Assistance Program (MSRFAP)** – The Medical Student/ Resident Financial Assistance Program was announced by the Manitoba government on May 18, 2001. Manitoba Student Aid administers the Educational Assistance Option of the MSRFAP on behalf of Manitoba Health. Conditional grants of \$15,000 are offered to undergraduate third and fourth-year medical students. Grants of \$20,000 are offered to medical residents in either year of Family Medicine. Residents in other approved residencies are eligible for \$20,000 a year for two years. Upon completion of their training, physicians who have participated in the program are required to work in Manitoba for one year for each grant they receive. Third year undergraduates who receive assistance are required to return one full year of service in a rural community in Manitoba.

**Aboriginal Education Awards** – The Aboriginal Education Awards were introduced in 2001as a three-year pilot project to assist Aboriginal students attending public post-secondary institutions in Manitoba with costs such as tuition, books, and supplies for the academic year. In February 2004, the Aboriginal Education Awards program was extended to the end of the 2006/2007 fiscal year. Funding was increased from \$75,000 per year to a maximum of \$150,000 based on matching funds from the Business Council of Manitoba and the Government of Canada. Aboriginal students may qualify for an award if they plan to attend a post-secondary institution and maintain full-time studies or at least 60% of a full course load. Awards are based on a combination of need and merit. Recipients of the awards may have an opportunity for part-time or summer employment with one of the Business Council's member companies.

**Aboriginal Languages of Manitoba Incorporated** – The Province provides grant funding to this non-profit organization which promotes the retention and preservation of Manitoba's seven Native languages in schools, public post-secondary institutions and communities.

**Churchill Northern Studies Centre** – The Department provides an annual operating grant to this non-profit organization with its mandate to provide inter-disciplinary field research facilities and logistical support to promote and facilitate education and research of the North and the Arctic.

**Youth Transition Program** – In co-operation with MB4 Youth, the Youth Transition Program provides recent eligible high school graduates with up to twelve months of paid work experience in the Manitoba government to encourage them to pursue post-secondary education. Graduates receive a \$3,000 bursary when they successfully complete their work experience and enroll in a designated post-secondary institution.

Figure 24: CSL/MSL Recipients by Gender






Figure 25: CSL/MSL Recipients by Ancestry

#### **Historical Overview of Student Debt**

The charts in Appendix D apply only to Manitoba Student Aid recipients. The bursaries considered are the Canada Millennium Scholarship Bursary (CMSB) and the Manitoba Bursary (MB), as these bursaries are used to remit loans. Debt is the total of CSL and MSL, minus CMSB and MB. The average debt does not equal the average loan minus the average bursary, since not all students receive bursaries.





Figure 30: Number of Students Represented in Figure 29.



The total accumulated loans are increasing each year for students. However, the CMSB (established in 1999/2000) and the Manitoba Bursary (established in 2000/2001) are helping reduce students' debt each year. The number of Manitoba Student Aid recipients in the last year of their programs has remained close to 4,000.

The four-year university degree program excludes dentistry, optometry, medicine, pharmacy, chiropractic and veterinary programs.


The maximum combined effect of the CMSB and MB awards was realized in 2003/2004 for students in four-year programs. The debt dropped from \$18,700 in 1999/2000 to \$17,600 in 2004/2005. The number of Manitoba Student Aid recipients in their last year of a four-year program ranged between 600 and 755 during this time.


**Figure 33:** Student Aid Utilization Rates (based on full-time enrollments at major public universities and community colleges)
