## New Liquor Licences

New liquor licences take effect April 1, 2006. By the time you receive this bulletin, most of you will have received your new licences in the mail. In the rare instance where we did not receive the required fees and renewal documents by March 1, 2006, reminders have been faxed or mailed. In some cases follow-up telephone calls have been made.

If you have not yet received your licence(s), please contact the Licensing Branch immediately at (867) 667-5245 to review the status of your licence(s) for the new year.

## Keep Us Informed

Now that the licence renewal season is virtually wrapped up, we would like to remind you that there may be other times during the year when we'll need to hear from you. We rely on you, the licensee, to keep us informed of changes that may affect your licence and your establishment's operation. By advising us promptly, it will assist us in keeping your file and licence(s) current and in doing so, meet the requirements of the *Liquor Act and Regulations*. If you plan to make any changes in your licenced premises that will affect the information endorsed on your licence, you must notify us, and in some instances receive specific approval. Changes may involve:

- ◆ new manager and/or addition of manager;
- ◆ structural alterations (renovations, additions);
- ◆ permanent or temporary additions (bandstand, stage, dance floor, service counter, etc.);
- ◆ increase or decrease in the number of games;
- ◆ licensee name (ie: change in company name);
- ◆ ownership (ie: purchase/sale of premises or sale/transfer of shares);
- ◆ hours of liquor sales.

## Drink Recipes

### Income Tax

1 oz Gin  
dash sweet vermouth
