Did You Know...

The legal drinking age in the Yukon is 19.

You must be at least 19 years of age to:

- Enter a cocktail lounge (bar);
- Purchase liquor from a licensed establishment or liquor store; or
- Consume liquor, except in specific restricted circumstances

You must produce acceptable identification as proof of age when requested.

Acceptable Forms of Identification

Acceptable ID is a Yukon Liquor ID Card or a driver's licence (with photo).

And, if further pieces are asked for, you could show one or more of the following:

- Passport;
- Canadian Citizenship Card;
- Firearms/Acquisition Certificate;
- Health Care Card;
- Social Insurance Card; or
- Credit Card.

More than one piece of ID may be requested to help confirm your age and identity.

If you refuse , or cannot provide, proof of age and refuse to leave a liquor store or a licensed establishment, it may result in a fine. This also may put the licensed establishment's liquor licence in jeopardy.



What Happens If you Produce a Fake ID?

If a YLC Liquor ID or Driver's Licence is fake or altered, it can be confiscated and the RCMP alerted. This offence may result in a fine of \$100 - \$125.

Minors - What Can Happen?

If a minor (a person under the age of 19) is :

- Found consuming or purchasing liquor, it may result in a \$100 fine.
- Found in a cocktail lounge (bar), it may result in a \$50 fine.

How to Apply for a YLC Liquor ID Card

If you are 19 years or over and would like to obtain a YLC Liquor ID Card, you may apply at any of the YLC Liquor Stores. The store locations are listed on the reverse side.

To apply, you must complete an application, and submit it with your:

- Birth Certificate;
- Certificate of Baptism (recording the date of birth); or
- Passport,

Along with your:

- Driver's Licence;
- Health Care Card;
- Social Insurance Card; or
- Visa (issued by a foreign government).

You can apply at any of the YLC Liquor Stores.

The cost is \$5.00 plus GST, and may be paid by debit card, Visa, MasterCard or cash.

It is an offence under The Yukon Liquor Act to supply false information or to use false identification in an application for a YLC ID Card. If the application is proven false , it could result in a fine.
