In Board Order 2006-5 regarding the review of YEC's 20-Year Resource Plan, the Yukon Utilities Board (Board) established the procedural schedule for this proceeding. The schedule includes a Public Workshop which will be held on Tuesday, July 25, 2006, commencing at 9:00 a.m. The venue for the workshop will be the High Country Inn, 4051-Fourth Avenue, Whitehorse, Yukon.

The Board recognizes that the procedural schedule established for this proceeding is somewhat condensed. Further, both the Pre-hearing Conference and Hearing dates were set as tentative. As a result, the Board is seeking input from interested parties on the procedural schedule. The Board expects that this will assist with the discussion of scheduling at the Public Workshop. The Board invites comments from parties on the schedule as soon as possible, but no later than July 21, 2006, which is the deadline for parties to register with the Board.

In the schedule, the Board included a step for Board staff to issue preliminary Information Requests to YEC, which Board staff has done. YEC has until July 21, 2006, to respond to these preliminary Information Requests. Copies of YEC's responses will be available at the Public Workshop.

At the Public Workshop YEC will present a summary of YEC's Resource Plan and associated documents during the morning. During the afternoon, Board staff will lead a workshop which will include the following:

- responding to questions on procedural matters
- hearing submissions on the issues and scope of the proceeding
- discussing Intervenors' status and Intervenors' cost-recovery process

- discussing scheduling and issues for the Pre-hearing Conference
- responding to questions, if any, on the Board staff's preliminary Information Requests sent to YEC prior to the Public Workshop.

An agenda for the Public Workshop is attached.

Following the Public Workshop, the Board will finalize the date for the Pre-hearing Conference, which is tentatively scheduled for August 4, 2006.
