Dear Mr. Morris,

RE: Yukon Energy Corporation (Yukon Energy) 20 Year Resource Plan YUB Application

I am requesting the Board extend today's deadline for an Intervention Requests for the following reasons.

Concerned residents of Marsh Lake may not effectively or responsibly formulate and file an intervention application, pursuant to your Rules of Procedure, prior to a public workshop, which is scheduled for July 25th, and a meeting of the concerned residents. Yukon Energy today has filed its answers to the Board's questions, a substantial document that in a couple of sentences references the existence of major concerns from Marsh Lake residents, but literally does not address any of the issues brought forth to date. This document has yet to be viewed by the residents of neither Marsh Lake nor the Board, I presume.

The Board states in its Rules under the heading the Scale of Costs that "the Board welcomes and relies upon informed and effective intervention from interveners representing different classes of customers of a utility to test the various aspects of the applicant's rate case". The Board's time line in conjunction with Yukon Energy timing for the dispersion of their Plan and responses from the Board's questions does not provide sufficient time to meet the spirit and intent of the Board's rules with respect to intervention.

In addition the Board states in its Rules "individuals or organizations including municipalities, who wish to intervene in any proceeding and who may have substantially common interests, are encouraged to combine their intervention to reduce both hearing time and aggregate costs". This objective can not be met until there is a public workshop and the community of Marsh Lake has time to discuss the issues and residents provide direction to its elected stewards, the Marsh Lake Local Advisory Committee (the LAC).

I have had conversations with a number of residents who wish to intervene in some sort of collective capacity. The problem is they do not have the information available to effectively discuss their intervention strategy nor have they had a chance to meet with the LAC to discuss and provide direction to their representatives. The LAC is scheduled to meet next in August. The last time they had a meeting was prior to the Board's published timelines.

If it is required that residents of Marsh Lake file an intervention request today, consider this letter that request but please provide us sufficient time to formulate our concerns and to meet all the obligations outlined in the Rules. As far as attending the Public Work Shop, I may be out of town on the date set but I am sure someone may attend on behalf of residents. It would be preferred if there was a public workshop held in the community of Marsh Lake to address the local concerns and the significant potential impacts as a result of what is being proposed.
