1 The *Personal Care Services Insurance and Administration Regulation, Manitoba Regulation 52/93, is amended by this regulation.*

2(1) Subsection 6(1) is amended by striking out "\$60.20 per day effective August 1, 2001" and substituting "\$61.40 per day effective August 1, 2002".

2(2) Subsection 6(2) is amended by striking out "\$25.80 per day effective August 1, 2001" and substituting "\$26.30 per day effective August 1, 2002".

3 Subsection 6.1(3.1) is amended by replacing items 1 and 2 with the following:

1. If the insured person's net income is between \$12,783.06 and \$26,366.98, that income is to be reduced by 5.66038% for the purpose of calculating the reduction under subsection (1) or (2).

1 Le présent règlement modifie le *Règlement sur l'assurance relative aux services de soins personnels et l'administration des foyers de soins personnels, R.M. 52/93.*

2(1) Le paragraphe 6(1) est modifié par substitution, à « 60,20 \$ à compter du 1^{er} août 2001 », de « 61,40 \$ à compter du 1^{er} août 2002 \$ ».

2(2) Le paragraphe 6(2) est modifié par substitution, à « 25,80 \$ à compter du 1^{er} août 2001 », de « 26,30 \$ à compter du 1^{er} août 2002 ».

3 Le paragraphe 6.1(3.1) est modifié par substitution, aux points 1 et 2, de ce qui suit :

1. Aux fins du calcul de la réduction que prévoit le paragraphe (1) ou (2), le revenu net de l'assuré est réduit de 5,66038 % s'il se situe entre 12 783,06 \$ et 26 366,98 \$.

2. If the insured person has a spouse who resides outside of a health facility and the spouses' combined net income is between \$35,349.06 and \$48,211.98, that income is, for the purpose of calculating the reduction under subsection (3), to be reduced by an amount equal to 5.66038% of the combined net income minus \$22,566.

4 **Clauses 6.2(2)(b) and 6.3(2)(b) are amended by striking out "\$25.80" and substituting "\$26.30".**

5 **Clause 6.4(1)(b) is amended by striking out "\$22,232. plus \$7,200." and substituting "\$22,901. plus \$7,200.".**

6 **Schedule B is replaced with Schedule B to this regulation.**

Coming into force

7 **This regulation comes into force on August 1, 2002.**
