# Letter to Public Health staff providing an update on the rifampin/ciprofloxacin depot system

The following letter provides an update on the system of rifampin/ciprofloxacin depots now in operation for prophylaxis of contacts of cases of invasive meningococcal and haemophilus influenzae disease.

There are 10 hospital pharmacy depots across the province, plus Tache Pharmacy in Winnipeg which will maintain rifampin and ciprofloxacin stores with extended hours of availability (see list following).

During regular hours there will be a pharmacist available to dispense medication. After regular hours medication will be accessible to emergency room and public health nurses through special prepackaged and labeled stock in the emergency room. At several depots (see notes listed below) a pharmacist will be available on a call back basis on evenings, holidays and weekends if required (e.g. for preparation of pediatric rifampin suspension which is not stored in the emergency room).

Medication as well as information sheets on meningococcal and haemophilus influenza B disease and potential side effects of rifampin and ciprofloxacin will be distributed to each contact as appropriate.

To release medication, the MOH should call the depot closest to where the majority of contacts reside and identify him/herself as a Medical Officer of Health wishing to release rifampin or ciprofloxacin from the provincial depot system. Provide the information outlined on the attached "Meningococcal Contact Form" to the pharmacist for each person to be prophylaxed, indicating as well where the medication is to be sent. Regional Public Health Nurses may provide advice about distribution of medication (ie. whether will be done by Emergency Room Nurses in outpatient department or by Public Health Nurses at the same or at different location).
