INTRODUCTION

This index is an index to the *Rules of the Supreme Court of the Northwest Territories*, established by regulation numbered R-010-96. The Rules have been analyzed rule by rule, and index entries composed to summarize the contents of each rule. These entries appear under one or more subject headings.

The index contains both general and specific subject headings. Therefore, it may be necessary to look at more than one heading to find all relevant references. For example, **PLEADINGS, ORIGINATING DOCUMENTS** and **ORIGINATING NOTICES** are all headings that may relate to the same subject in more or less detail. Cross references indicate related subject headings or subheadings.

Forms are listed alphabetically under the heading **FORMS**. They are also indexed by subject with their corresponding rules. All other references are to rule numbers.
