

REPORT OF THE FIRE MARSHAL

The Fire Prevention Act 1989 assigns the Office of the Fire Marshal authority and responsibility for the provision of fire safety in buildings and for safe storage of flammable and combustible materials. The Office advises various levels of government on fire-related matters, including fire protection. The Office is also responsible for the safe installation and usage of propane and electricity.

The Office of the Fire Marshal, as a division of the Nova Scotia Department of Labour, emulates the department's vision and mission statements. To achieve our goals, staff participated in the Department of Labour's Commitment to Quality Program. To meet the previous year's task team recommendations, the following activities were undertaken.

- The Fire Prevention Act, Electrical Installation and Inspection Act, Liquid Petroleum Gas Installation, and Equipment Regulations and all subsequent legislation have been reviewed by stakeholder groups who have presented recommendations for changes to the government.

- The first fire prevention symposium was held in October, sponsored by this office, the Fire Inspectors Association, and Halifax Regional Fire Service.

- The Office has been involved with the proposed natural gas pipeline and consumer service as both a regulator and advisor on public safety and fire department pre-planning.

- The regionalisation program for all deputy fire marshals continued with the opening of an office in Yarmouth.

A number of other programs are under study so that we may provide a higher level of life safety in an effective and efficient manner.

EDUCATION

The introduction of the Learn Not to Burn Program in Nova Scotia continued through the efforts of the committee. The Child Care Foundation of Canadian Tire Incorporated has provided assistance to the fire service and taken part in special programs such as campaigns to decrease fat fires. Fire departments, school teachers, daycare personnel, and the Department of Education are involved in introducing the program into the education system.

The Nova Scotia Accreditation Board was formed in 1997 to provide for certification of firefighters in Nova Scotia. The Board has representatives from the Fire Officers Association of Nova Scotia, Nova Scotia Firefighters School, Cape Breton Regional Fire Service and the Halifax Regional Fire Service. The Board has applied for accreditation from the International Fire Service Accreditation Congress.

The L.P. Gas Board of Examiners has the responsibility to certify and advise on disciplinary matters for all those employed in the propane industry. The Board held 11 meetings and invigilated 584 examinations.

A committee has been formed with representation from various organizations to develop Occupational Health and Safety legislation for firefighters in conjunction with provincial legislation.

The Office provided training programs to industry, institutions, government, and the fire service.

Staff attended 26 fire service functions, held 74 meetings with fire chiefs, and took part in 4 public fire safety displays.

ENGINEERING

The Office continued to provide a system for approving plans for building construction, and propane and electrical installations. The system provides for both the provision of advice and the inspection of the site, where possible. Many of the province's architects, engineers, building inspectors, and contractors rely on this service to ensure that they meet the requirements for fire and life safety in their buildings. Following is a breakdown of these activities.

This Office provides commentary and represents the province on a number of standards writing organizations including the Commission on Building and Fire Codes, the Canadian Standards Association, Underwriters' Laboratories of Canada, Underwriter Inc., the Canadian Gas Association, and the Standards Council of Canada. These organizations and others form a critical component of the safety model.

ENFORCEMENT

To ensure compliance with legislation, the Office carries out inspections by request, complaint, and audit. The Office was required to prosecute individuals during the past year for failure to comply with an order under the Fire Prevention Act. The Office will investigate to assist local authorities, or where there are indications that fires or explosions were caused by non-compliance or illegal action.

There were 150 fires with a monetary loss of \$1,109,380 attributed to arson or suspected incendiary fires. This was down from 135 fires and \$2,160,406 in the previous year.

INJURIES AND LOSS OF LIFE

Despite the efforts of our fire protection system, 11 lives were lost: 10 civilians (6 men and 4 women) and 1 firefighter. Injuries to 18 civilians and 4 firefighters were reported.

PROPERTY LOSS

The recorded fire loss for the year was \$14,215,893 as the result of 1,882 reported fires. This compares with losses of \$26,423,155 from 2,056 fires in the previous year, a decrease of 46 per cent in dollar loss and a decrease of 9.8 per cent in fires.

The major known causes of fire were:

- heating equipment—431 fires and \$1,044,422 in losses
- cooking equipment—161 fires and \$832,343 in losses
- vehicle—electrical—75 fires and \$103,240 in losses
- smoking material and open flame—63 fires and \$963,939 in losses

There were 461 fires of an undetermined nature. These accounted for \$4,307,328 or 30.2 per cent of our monetary losses and 24.5 per cent of our reported fires.

SUMMARY

The per capita loss was \$15.02, compared to \$35.68 in the previous year (a decrease of \$20.66).

Every home should be protected by a working smoke detector or alarm, and every business should protect its resources with fire protection equipment including sprinklers. Every citizen should be educated to prevent fire or to escape its path. Every firefighter should be provided with the training and equipment required to face the worst possible situations.

My sincere appreciation goes to the provincial fire service, industrial fire brigades, the Canadian Armed Forces, and all other fire prevention and fire protection services for their cooperation throughout the year. I thank the municipal authorities, the insurance industry, the Insurers' Advisory Organization, Insurance Crime Prevention Bureau, Royal Canadian Mounted Police, all municipal police forces, and the media for their continued cooperation and efforts.

I thank the people of Nova Scotia who in many ways assist in fire prevention and protection and who support their local fire service.
