What is Tobeatic Wilderness Area?

Tobeatic Wilderness Area is a provincial protected area located in the interior of southwestern Nova Scotia. The Tobeatic was designated in 1998 as one of 31 Wilderness Areas in Nova Scotia. It is managed by Nova Scotia Environment and Labour (NSEL) in partnership with the Nova Scotia Department of Natural Resources.

The Tobeatic Wilderness Area covers 104 000 hectares in Annapolis, Digby, Yarmouth, Shelburne and Queens counties. It includes portions of five natural landscapes, and protects the headwaters of nine river systems that flow to both the Atlantic and Fundy coasts. It contains naturally functioning ecosystems including barrens, semibarrens, wetlands, pioneer and old forest; and remote lakes, streams and stillwaters.

What are the objectives of a Wilderness Area?

The primary objectives of a Wilderness Area are to protect natural processes, biological diversity, and outstanding natural features. Activities such as wilderness recreation, environmental education and scientific research are encouraged. Sport fishing and traditional patterns of hunting and trapping are also generally permitted.

What is a management plan?

A management plan is a strategic document that guides the management direction of a protected area. It sets out issues, objectives, strategies, and priorities for all aspects of management including conservation, development, communication, and operation.

The basic management structure for all designated Wilderness Areas is laid out in the *Wilderness Areas Protection Act*. Our goal is to develop a comprehensive and integrated management plan for the Tobeatic Wilderness Area. Management planning is an opportunity for the Department to work cooperatively with the public to effectively achieve the Wilderness Area objectives.

What is included in a management plan?

Generally, a management plan will include background information on natural, cultural and recreational values. It will rely on the best available information for topics such as natural ecosystems and functions, biodiversity, human history and wilderness recreation.

Working within the context of the *Act*, the management plan will address specific issues, and provide the strategic direction to the managing authority for site management and long-term planning. It will guide the delivery of shared benefits of Wilderness Area designation, through the development of partnerships for implementation.

What is the role for interested citizens?

The Protected Areas Program is built on a foundation of public participation. Management plans are prepared with a high degree of public involvement, with several opportunities for the public to provide comment and review materials.

How will public consultation for Tobeatic Wilderness Area work?

We value public participation and look forward to continuing to work together with all interested persons or organizations.

A variety of tools will be used including an Advisory Group, a newsletter, and a series of public Open Houses. We will be seeking public comment regarding (i) Issues & Objectives, and (ii) Strategies & Priorities. This input will be compiled, reviewed and incorporated in the development of the management plan.

To date, one round of public consultation has been completed and the Advisory Group for Tobeatic Wilderness Area has provided valuable advice on content for NSEL to develop a Draft Management Plan. Local Open Houses will be held this spring for people to learn more about Tobeatic, and to provide their comments.

What is the Tobeatic Advisory Group?

The Tobeatic Advisory Group (TAG) was established in December 2001 by the Minister of Environment and Labour to advise on matters pertaining to the management plan for Tobeatic Wilderness Area. This volunteer group has assisted the Department throughout the Tobeatic Management Planning Exercise.

The Tobeatic Advisory Group held its initial meeting in March 2002, and has been very active throughout 2002 and 2003 to provide advice to NSEL on content for the Draft Management Plan.

Careful consideration went into the establishment of the Tobeatic Advisory Group. Every effort was made to create an effective working group that fairly represents the range of interests in Tobeatic Wilderness Area.
