Halifax Metro's January 2004 all-items CPI index of 122.8 (1992=100) was up 0.1% from last month and increased by 0.7% on a year over year basis.

Nova Scotia

- ! Nova Scotia's overall monthly price index increased 0.1% in January; it increased 0.4% over January 2003.
- Notable increases for the previous month were recorded for:
 -non-alcoholic beverages (+12.9%); preserved fruit and fruit preparations (-5.7%)
 -fuel oil and other fuel (+5.2%); gasoling (+3.7%)
 - - -homeowners' insurance premiums (+2.7%)
 - -purchasing and leasing of automotive vehicles (+0.3%)
- Since last month offsetting price declines of particular note included:
 - -footwear (-10.1%); women's clothing (-3.3%)

- -fresh or frozen beef (-5.1%)
 -inter-city transportation (-3.3%)
 -recreational equipment & services (excl. vehicles) (-2.6%)
 -automotive vehicle insurance premiums (-1.7%)

- From December 2003 to January 2004, all-items CPI increased 0.1% in Canada; Canadians paid 1.2% more for the goods and services contained in the CPI basket than they did a year ago.
- Since last month higher prices contributing to the month-over-month increase included:
 - -gasoline (+5.7%)—price increases were widespread across provinces ranging from 1.9% in BC and NL to 7.8% in AB, while PE remained stable.

 - -non-alcoholic beverages (+5.9%)-increases in all provinces as prices returned to normal after holiday promotions. -fuel oil (+10.0%)-partly due to stronger demand resulting from cold temperatures and higher crude oil prices. Increases were noted in all provinces, with the strongest in QC (+14.4%) and ON (+13.7%).
- Lower prices that moderated the rise included:

 - -natural gas (-9.3%)—mostly under the pressure of price declines in ON
 -travel tours (-11.0%)—January is a lower month of demand compared to February and March
 -air transportation (-4.8%)—price decreases are usual in January as they are compared to high season fares in December.
 - -other items that experienced a price decline included fresh fruit, sporting and athletic equipment and men's clothing

- Since last month higher prices contributing to the month-over-month increase included: -Gasoline Prices +3.4%, from 2.1% in Ontario to 7.7% in Manitoba -Travel Tours +11.9%, similar to the last five years
- Lower prices that moderated the rise included: -Purchase of Automobiles -1.9%, due to rebates and discounts

- Since last month offsetting price declines of particular note included:

- From February to March 2004, all-items CPI increased 0.3% in Canada, the largest monthly advance since March 2003; Canadians paid 0.7% more for the goods and services contained in the CPI basket than they did a year ago.
- Since last month higher prices contributing to the month-over-month increase included:

 - -travel tours (+5.5%)-typical increase this time of year -gasoline (+2.7%)-widespread across provinces and ranged from 0.6% in ON to 7.2% in AB -women's clothing (+2.0%)-mostly due to price increases on new summer stock & return to regular prices from discounts -automotive vehicles (+0.3%)
- ! Lower prices that moderated the rise included:
 - -computer equipment & supplies (-2.6%)
 - -natural gas (-2.5%)-mostly under pressure of price declines in AB -meals from fast food & take-out restaurants (-0.8%)

- ! Nova Scotia's overall monthly price index increased 0.1% in April; it increased 1.0% over April 2003.
- Notable increases for the previous month were recorded for:
- -cigarettes (+5.5)
 - -fresh or frozen chicken (+5.5%); bakery products (+3.5%) -inter-city transportation (+2.9%)

 - -child care and domestic services (+1.9%)
 - -automotive vehicle parts, maintenance and repairs (+1.3%)
 - -fuel oil and other fuel (+0.8%)
- Since last month offsetting price declines of particular note included:

 - -men's clothing (-5.2%); women's clothing (-4.2%) -fresh vegetables (-4.6%); processed meat (-3.2%); fresh fruit (-2.8%) -recreational equipment & services (excl. vehicles) (-1.5%)

 - -homeowners' maintenance & repairs (-0.8%)

- From March to April 2004, all-items CPI increased 0.2% in Canada; Canadians paid 1.6% more for the goods and services contained in the CPI basket than they did a year ago.
- Since last month higher prices contributing to the month-over-month increase included:
- -electricity (+3.3%)—mostly attributable to a 5.7% increase in Ontario along with a 6.5% increase in British Columbia
- -natural gas (+3.2%)-almost completely attributable to removal of the provincial government rebate program in Alberta
- -gasoline (+1.5%)—fourth consecutive monthly increase as crude oil prices continued to rise -automotive vehicles (+0.7%)—some manufacturers adjusted their incentive programs
- Lower prices that moderated the rise included:

 - -fresh vegetables (-6.0%)—some crops became available from Canadian hot-house producers
 -computer equipment & supplies (-3.2%)—result of decreased prices for both desktops and laptops
 -women's clothing (-2.6%)—result of widespread sales in most categories—decreases were noted in all provinces
 -men's clothing (-1.4%)—widespread sale prices moderated by introduction of new seasonal clothing items
 -automotive vehicle insurance premiums (-1.3%)—result of decrease in Ontario and Prince Edward Island

 - -fresh vegetables (-4.4%); fresh or frozen pork (-3.1%); bakery products (-2.4%) -women's clothing (-2.8%) -personal care supplies & equipment (-0.9%)

- From April to May 2004, all-items CPI increased 0.9% in Canada; Canadians paid 2.5% more for the goods and services contained in the CPI basket than they did a year ago.
- Since last month higher prices contributing to the month-over-month increase included:
 -gasoline prices (+13.6%) highest monthly rise since June 1983 (+19.1%); increases seen in all provinces ranging from
 +3.6% in Prince Edward Island to +17.5% in Manitoba
 -traveller accommodations (+7.9%) introduction of summer rates
- -air transportation (+5.7%) partly due to seasonal changes in rates and rising fuel costs -fresh fruits prices also contributed to the upward pressure due to poor weather in the growing regions of producer countries
- Lower prices that moderated the rise included:
- -women's clothing (-3.3%) due to widespread sales in most categories of women's clothing -index for seeds, plants and cut flowers (-4.0%) widespread sales were reported on many categories

- -women's clothing (+2.3%)
- Since last month offsetting price declines of particular note included: -men's clothing (-2.4%) -processed meat (-2.0%)

- From May to June 2004, all-items CPI increased 0.1% in Canada; Canadians paid 2.5% more for the goods and services contained in the CPI basket than they did a year ago.
- Since last month higher prices contributing to the month-over-month increase included: -meat (+4.0%) - resulting from +4.6% increase for beef as re-established pricing to levels comparable with those prior to the discovery of mad cow disease in Alberta, higher chicken prices as lower supply pushed the index up +5.4% due to British Columbia's avian flu outbreak and stronger demand for pork increased pork prices +5.7% -natural gas (+8.0%) - rise entirely the result of a 38.5% increase in Alberta mostly due to higher costs for gas recovery -traveller accommodation (6.0%) - rise ranged from 3.2% in Saskatchewan to 10.5% in Nova Scotia with onset of peak tourist
 - season across the country
- Lower prices that moderated the rise included: -gasoline (-3.3%) - largest decreases were registered in Ontario (-5.5%) and Quebec (-4.9%) while increases were observed in PE, NL, NB and MN

 - -fresh vegetables (-8.5%)-lower prices for lettuce and tomatoes -automotive vehicle prices (-2.6%)-manufacturers provided incentive programs to help reduce stock before arrival of new models
