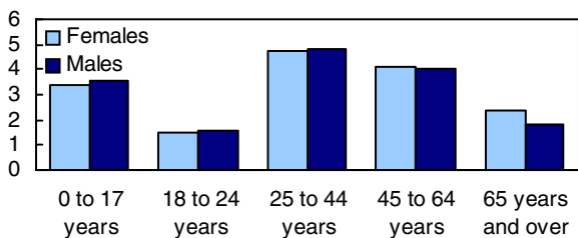

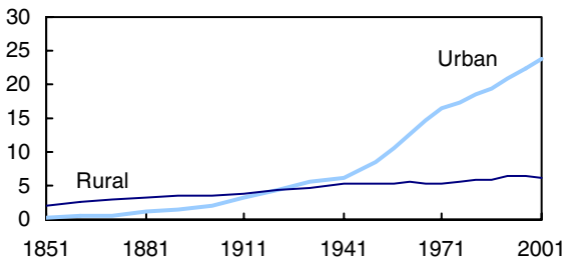

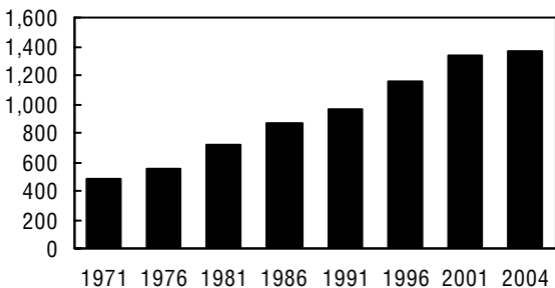
Population urban and rural, Canada

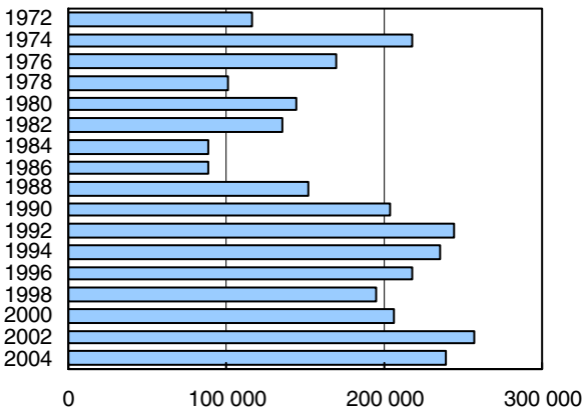

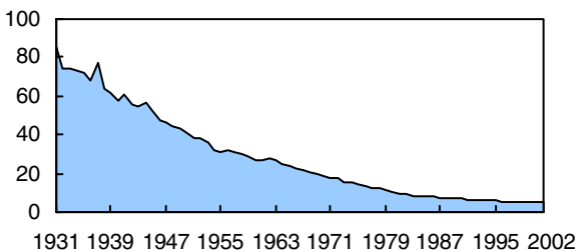

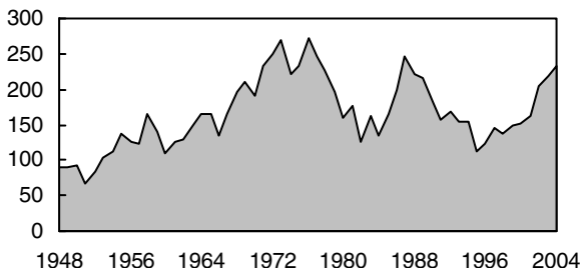

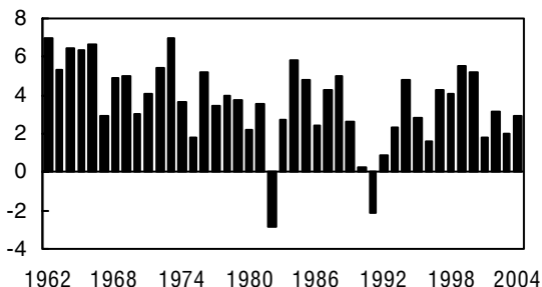

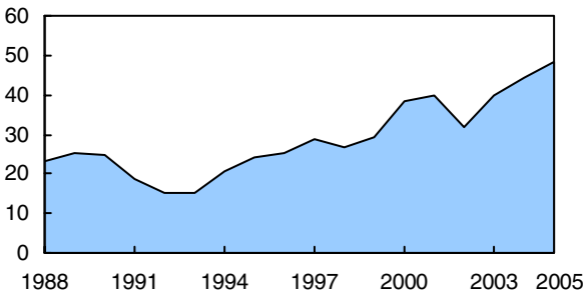

Quarterly operating profits of Canadian enterprises

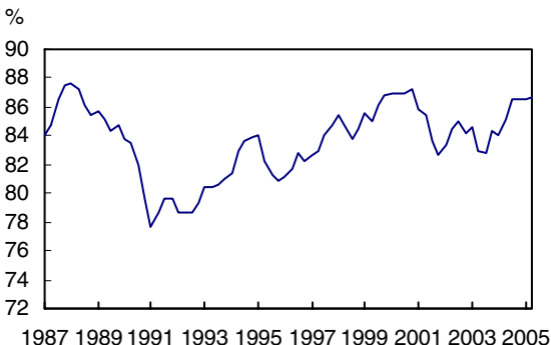

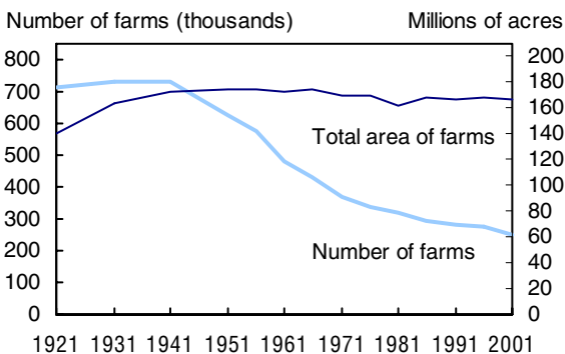

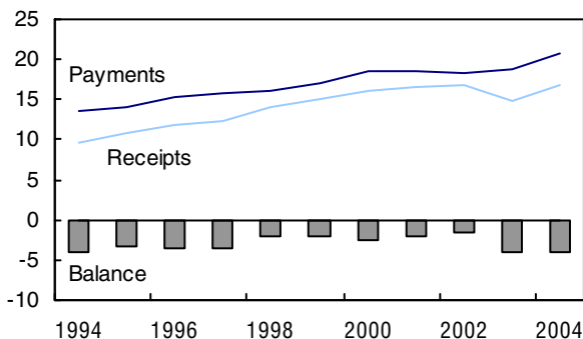

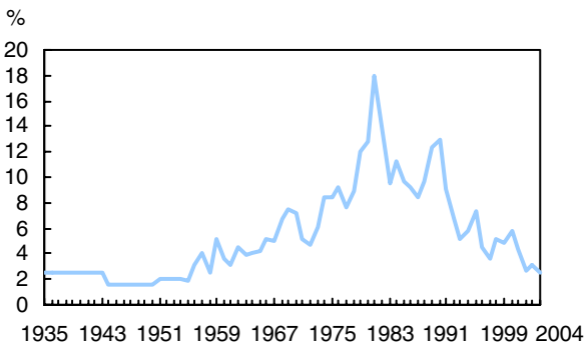

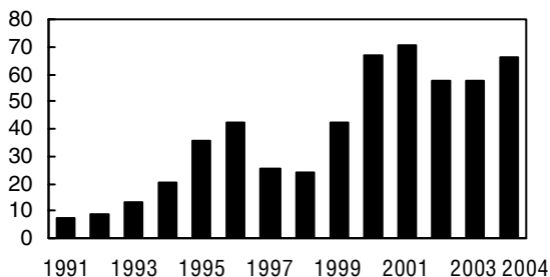

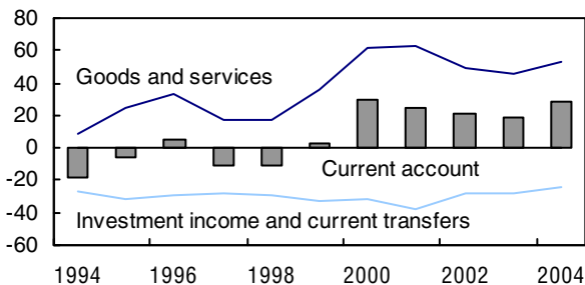

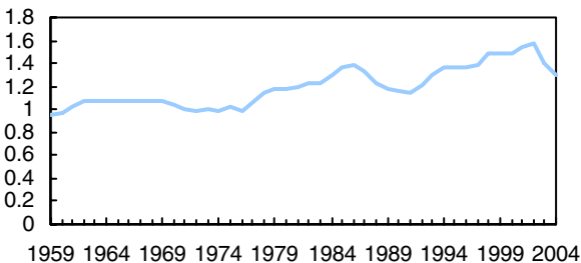
Current account balances

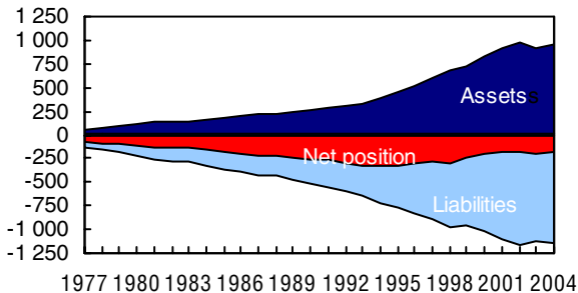

What is a Census?

In Canada the census is conducted every five years. A census provides a statistical portrait of a country and its people. The next Canadian census is May 16, 2006. All households will receive a census questionnaire which is to be completed and returned online at www.census2006.ca, or by mail in the pre-addressed yellow envelope provided, by Census Day.

Why is the Census important?

The national census provides a unique source of information about Canada and its population. The census is the only source of reliable detailed data for specific groups (such as lone-parent families and ethnic groups) and for areas as small as a city neighbourhood or as large as the country itself.

Census results are used to:

- make decisions about Canada's economic and social needs
- allocate seats in the House of Commons
- calculate federal transfer payments to the provinces and territories
- develop programs such as day-care and subsidized housing
- assess the need for community programs and services.

Canada owes the success of its statistical system to a long-standing partnership between Statistics Canada, and the citizens of Canada, its businesses, governments and others institutions.
