# FARM INCOME SITUATION, (2004)<sup>p</sup> AND OUTLOOK (2005)<sup>E</sup>

### MANITOBA HIGHLIGHTS

#### Situation 2004:

- Manitoba farm cash receipts are estimated at \$3.72 billion in 2004, a 5.2% increase from \$3.54 billion in 2003.
- In 2004, crop cash receipts increased by 1.8% to \$1.71 billion from almost \$1.68 billion in 2003. Higher Canadian Wheat Board payments helped to offset lower prices for the major crops, with the exception of canola which had higher prices and lower marketings.
- Livestock receipts were estimated at \$1.552 billion in 2004, close to the 1.553 billion estimated for 2003. Hogs accounted for an estimated 61% of the 2004 livestock receipts, and are record high at \$941.8 million (25% higher than last year). Cattle and calves account for approximately 12% of the livestock receipts. The market for cattle and calves has been under duress since May 2003, and both prices and marketings declined from 2003. Cattle receipts were 50% lower than last year at \$144.5 million and calves were 37% lower at \$35.2 million.
- Direct payments to Manitoba producers totalled \$461.7 million in 2004, a 50% increase from \$308.1 million in 2003, due to increased payments from Crop Insurance and the Net Income Stabilization (NISA) withdrawals, as well as payments from the Transition Industry Support Program, BSE-related programming and the Canadian Agricultural Income Stabilization Program (CAIS).
- Farm operating expenses increased to \$3.085 billion in 2004 from \$3.031 billion in 2003. Higher costs for most inputs were partly offset by lower livestock purchase and feed costs.
- Net cash income for 2004 is estimated at \$636.8 million, up 25.2% from \$508.7 million in 2003. Realized net income (after depreciation) more than doubled to \$212 million. Total net farm income decreased by nearly 40% to \$290.6 million, despite a small positive value of inventory change.

### Outlook 2005:

- Farm cash receipts may decrease by 6.4% to \$3.48 billion in 2005. Livestock receipts could rise by 11.4% to \$1.73 billion due to higher prices and increased sales. Receipts from crops may decrease by 17.4% to \$1.41 billion due to sharp price declines.
- In 2005, direct payments could decline by 25.6% to \$343.7 million as a result of reduced Crop Insurance and the phase-out of Canadian Farm Income (CFIP), reduced Net Income Stabilization (NISA) withdrawals, BSE-related and transition program payments. Increased CAIS payments in 2005 could more than offset reduced NISA withdrawals.
- Operating expenses are expected to rise 4.1% in 2005, but this has been reduced to an estimated 3.1% net increase by the Manitoba School Tax Rebate program. Increases in livestock and crop inventories could improve the value of inventory change over the year.
- In 2005, net cash income could be \$302.8 million, more than halved from the 2004 level. After depreciation and inventory change allowances the Total Net Income could decline to a negative \$16.2 million.




