

Proxy Voting Report August 10, 2006

Summary of Proxy Voting Activity

This proxy report covers 12 months ending June 30, 2006

CPP Investment Board voted in 2,366 meetings

- 543 related to Canadian companies
 - on average, we own about 2% of each company
- 801 related to U.S. and 1022 related to Non-North American companies
 - on average, we own about 0.05% of each company

CPP Investment Board voted on 12,393 agenda items

Supported management recommendations 82.5% of the time

Votes Against Management

The main issues where CPP Investment Board voted against management

- Equity compensation plan introduction or amendment
 - due to high cost, excessive dilution or inclusion of non-employee directors
- Supported Shareholder proposals
 - Require Majority Vote for Election of Directors
 - Declassify the Board of Directors
 - Separate Chairman and CEO Positions
 - Require performance based options
 - Restore or Provide for Cumulative Voting
 - Submit Shareholder Rights Plan (Poison Pill) to Shareholder Vote
 - Submit Severance Agreement (Change-in-Control) to Shareholder Vote
- "Routine" items
 - Abstain from accepting financial statements and discharging directors
 - Against transacting "other business" that is not on the agenda
