## Application for Veteran Plate Eligibility Certification

### Eligibility Criteria for Ontario Veteran Plate

Veteran plates are available to any person who has honourably (*please check applicable box under which you qualify*):

- A) Served in WWII or in Korea during the Korean war as a member of any of the following: the Canadian Forces, an allied force, the Merchant Navy or the Ferry Command.
- B) Served for a minimum of three years in the Canadian Regular Forces (may still be serving).
- C) Served for a minimum of three years of actual paid duty (1095 days) in the Canadian Reserve Forces or has been awarded the Canadian Decoration (CD) .
- D) Served in NATO operations or as a member of a United Nations peacekeeping force as a member of any of the following: the Canadian Regular or Reserve Forces, the Royal Canadian Mounted Police, another Canadian police force, or an allied force.
- E) Served in the Vietnam War in the forces of the United States or its allies during this war and who was a Canadian citizen at the time of such service.

**Instructions:** Mail completed form, photocopies of **proof of service**, fee and a **self addressed stamped envelope** to the Royal Canadian Legion Office to the address listed at the top of this application form. ### Section 2 - Additional Documentation Required

A photocopy of the following documentation **must be attached**:

- Retired Personnel** -Canadian Forces discharge certificate/certificate of service - both sides (or equivalent for Merchant Navy, Allied forces, etc.). Retired Reserve Force Personnel must provide proof of three years of paid duty (1095 days) or have been awarded the Canadian Decoration (CD).
- Serving Personnel** - Letter from the applicant's home unit confirming type of service (regular force or reserve force) and receipt of the Canadian Decoration (CD) **OR** 3 years (1095 days) of paid duty.
- Police Personnel** - Letter from the applicant's police service confirming their involvement in a NATO operation or a United Nations (UN) peacekeeping mission.
- Vietnam Service** - Statement of service or discharge certificate showing service in Vietnam during the Vietnam War in the United States forces or the forces of its allies during this war and proof of Canadian Citizenship at the time of service (Canadian birth certificate or Citizenship document, which shows date of becoming a Canadian citizen).

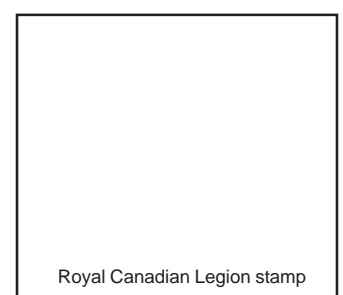

**Please Note:** To receive a Veteran plate, this application form (signed and stamped by the Royal Canadian Legion, Ontario Command) must be submitted, with all other required applications and documents, to your local Driver and Vehicle Licence Issuing office.
