Background


- Highways 1 & 3 are:
 - Part of the National Highway System (NHS)
 - future freeways in Alberta
- In 2000, Alberta Infrastructure & Transportation (AIT) took over direction, control, and management of Highways 1 & 3 through City
- AIT has retained Stantec Consulting Ltd. to:
 - 1. Identify possible improvements to existing Highways 1 & 3 through the City of Medicine Hat (Internal Route); and
 - 2. Develop functional plan for ultimate realignment of Highways 1 & 3 in vicinity of the City of Medicine Hat (External Route)
- Technical Review Committee is comprised of :
 - City of Medicine Hat
 Cypress County
 - Town of Redcliff

Study Area



Previous Studies

- 1982 "Highway 1 Hwy 524 to Medicine Hat" AIT
 - Identified a Highway 1 bypass of Redcliff
- 1998 "City of Medicine Hat Trans Canada Highway Planning Study" Stanley Consulting Group Ltd.
 - Developed interchange alternatives between 1st Street & 16th Street
 - Not adopted by City
- 2004 "Safety & Operational Review Highway 1 Town of Redcliff" Clifton ND Lea Consulting Inc.
 - Identified operational improvements
- 2005 "Highway 1 East Medicine Hat Boundary to Highway 41 North Hamlet of Dunmore" – CastleGlenn Consultants Ltd.
 - Developed access management strategy for the Dunmore area
 - Final report under review by AIT





Study Objectives

Internal Route

- Identify access management strategy to bring existing Highway 1 through Medicine Hat to national highway standards
 - 90 km/h posted speed limit
 - Free flow operations on highway
- Review access management strategy for Highway 3 within city
- Identify deficiencies on existing highways
- Recommend improvements to address deficiencies

External Route

- Identify ultimate realignment of Highways 1 & 3 to achieve freeway status (110 km/h posted speed limit)
- Identify future interchange locations and configurations
- Provide free flow connection between Highway 1 & 3





Study Tasks

Internal Route Only

- Review existing, 20-yr, & ultimate traffic projections
- Conduct Environmental overview
- Conduct noise assessment along Highway 1
- Develop & evaluate access management scenarios

External Route Only

- Develop & evaluate route alternatives
- Conduct environmental, historical, and geotechnical assessments
- Develop drainage master plan

<u>Both</u>

- Conduct Planning Stage Road Safety Audit
- Extensive public consultation phase
- Develop cost estimates
- Determine right-of-way requirements





Study Issues

Internal Route

- Existing highway through Medicine Hat does not meet NHS standards
 - Posted speed < 90 km/h
 - Signalized intersections at 6 Street, 16 Street, & Dunmore Road
- Right-of-way constraints due to:
 - Development
 - Service Roads/ Local Roads

External Route

- Irrigated land
- Country residential development
- Major agricultural operations
- Requires new crossing of South Saskatchewan River
