## Canada – South Africa Provincial Twinning Project

In late July Aniko Parnell, Director, International Governance Office and Mary Anne Wilkinson, Executive Director, Corporate Human Resource Strategy, Personnel Administration Office went to South Africa under the CIDA funded Canada – South Africa Twinning Project for a two-week program. In Alberta's sister province, Mpumalanga, they gave a performance management workshop to a large group of civil servants. The workshop was requested by Mpumalanga as a follow-up to Ms. Wilkinson's discussions with a delegation that visited Alberta earlier this year. It was viewed as a success by both sides and garnered a much larger crowd then was first anticipated.

Gerry Bourdeau, Deputy Minister, International and Intergovernmental Relations joined Ms. Parnell and Ms. Wilkinson in Mpumalanga the following week. Mr. Bourdeau met with the Director General of Mpumalanga, Advocate Stanley Soko to discuss the successes of the twinning and look at what future activities might be undertaken. It was a productive meeting that helped strengthen the ties between Alberta and Mpumalanga.

From Mpumalanga the delegation headed to the Western Cape for a conference on Best Practices sponsored by the Canada South Africa Twinning Project. The conference examined best practices resulting from the twinning project and included various presenters from both the South African and Canadian provinces. It highlighted the successes that have been achieved through the project and where future activities might be needed.

# China Public Sector Reform Project – UPDATE (Subproject: Central-Local Relations Reform)

In May 2000, the Canadian International Development Agency (CIDA) funded the China Public Sector Reform Project (PSRP) to help China increase capacity of its public service to formulate, implement and regulate new policies within the country's overall reform process.

In June 2001, the IGO became Project Leader for the Central-Local Government Reform sub-project under the PSRP initiative. Over the life of the two-year sub-project, this involved senior and midlevel central and regional government officials traveling to Canada to examine the Canadian federalism model for aspects that may be useful under China's reform agenda. The sub-project involved the Government of Canada (Western Diversification), and the governments of Manitoba (Finance), and Alberta (International and Intergovernmental Relations).

From Oct. 27, 2001 to Jan. 27, 2002, three Chinese officials were selected from the central State Committee on Public Sector Reform for a three-month Intern Program with sub-project partners. Interns completed case studies, putting forward recommendations for reforms in China based on their understanding of the Canadian model. These case studies formed the basis for the Policy Framework Document submitted to the China People's Congress for consideration.

While central-local government reforms proposed in the document will take several years to implement, the Chinese central government has already adopted some of the recommendations to re-align its relationship with regional governments. Particularly important has been the ability for regional governments to undertake their own restructuring initiatives to better meet needs of local stakeholders without approval of the central government. This first step is quite an achievement in China's decentralization process. The sub-project ended on June 30, 2002 and was considered viewed a success by central and regional Chinese partners, including the Chinese Minister of the State Commission on Public Sector Reform.

## **Ukraine World Bank Delegation**

From October 25 to 31, 2003, a 4-member delegation from Ukraine participated in a review of Canadian models for land titling and registration. Officials were members of the World Bank Land Titles Implementation Team, responsible for allocating the \$US190 million in World Bank funds provided to Ukraine. After a few days in Winnipeg, Manitoba, the delegation came to Edmonton, Alberta and met with public and



private sector officials. Delegation members were treated to a tour of Alberta's land titles office, along with an on-line demonstration of the new SPIN2 system.
