Part J of the Consolidated Practice Directions of the Court of Appeal is amended as follows:

2. by repealing paragraph 7(b);
3. by repealing the portion of paragraph 7(c) after the comma;
4. by repealing the portion of paragraph 7(d) after the word “appendices.”

3. Unless otherwise directed, the Maintenance Speak to List will consist of all appeals from Maintenance only where the notice of appeal is filed more than 10 business days prior to the speak to date.
