^{2.} Unless otherwise directed, the Civil Speak to List will consist of all Civil matters (excluding appeals from Maintenance only) where the appeal book has been filed or where six months has elapsed since the filing of the notice of appeal, whichever occurs first.

^{3.} Unless otherwise directed, the Maintenance Speak to List will consist of all appeals from Maintenance only where the notice of appeal is filed more than 10 business days prior to the speak to date.
