Unless otherwise directed, the Maintenance Speak to List will consist of all appeals from Maintenance only where the notice of appeal is filed more than 10 business days prior to the speak to date. As these dates are now being published, the Registrar will no longer send a letter notifying the parties or counsel of the next Speak To date.
