The AMIP supports the development, enhancement and rehabilitation of core capital infrastructure projects, such as municipal roads, bridges, public transit vehicles and facilities, water and wastewater systems and facilities, storm drainage systems and facilities, emergency service vehicles and facilities and infrastructure management system software. The program may include barrier-free transportation initiatives, such as the purchase of accessible vehicles, to improve accessibility for seniors and persons with disabilities. Cities Special Transportation Grant (CSTG)

The CSTG applies to Cities (Excluding Calgary and Edmonton) and the Urban Service Areas of Sherwood Park and Wood Buffalo and provides financial assistance for high priority transportation capital projects, including the purchase of accessible transportation vehicles, within cities where the project costs would be beyond the city's funding ability under other transportation grant programs.
