

Coal-Fired Power Plant Approval Process

Introduction

This fact sheet explains Alberta Environment's process for approving power plants that burn coal to generate electricity. Approximately two-thirds of Alberta's electricity is generated by coal.

Alberta Environment regulates a wide range of industrial facilities in the province under Alberta's *Environmental Protection and Enhancement Act* (EPEA), including coal-burning power plants. This is most commonly done through an Environmental Approval.

Under EPEA, any power plant that can produce more than one megawatt of electricity must have an approval from Alberta Environment. Coal-burning power plants must also have an approval issued under the *Water Act*, because they use considerable amounts of water.

Environmental Approvals

Environmental approvals are designed to ensure the environment is protected from a facility's operations. The approval sets out conditions for a facility's operations, including emission limits and the type of monitoring the facility must conduct.

How does a business or industry get an approval?

Any business or industry wanting to open a facility for which an environmental approval is required must apply to Alberta Environment. Before deciding whether or not to issue an approval and what its conditions should be, the department must first determine the potential effects of the proposed project on the environment. This involves an environmental review.

Environmental Review

Alberta Environment's environmental reviews ensure the department has the information and details it needs to determine a project's potential effects on the environment. The steps involved in the review process and the length of time it takes are determined by how much information the department needs.

Alberta's environmental reviews are open and they provide for full public participation, including public notification and opportunities to comment.

The review process for a situation where the effects are easy to determine will be simpler than the process for a situation where the effects are more difficult to determine. In cases where the effects are especially difficult to determine, the department may ask the project owners for an Environmental Impact Assessment (EIA) report.

Environmental Impact Assessment (EIA) reports

An EIA is the most comprehensive information-gathering tool Alberta Environment has at its disposal. The report looks at all aspects of potential environmental effects arising from the project and is prepared by the industry asking for the approval.

The need for an EIA is determined by the Director, Regulatory Assurance Division.

The Director's decision is based on the size and nature of the issues involved in determining the project's environmental effects. The Director can request information from the public, industry and other government agencies to help decide whether or not an EIA is necessary.

For some projects, an EIA report is mandatory. This is the case for any coal burning power plant that produces at least 100 megawatts of electricity. (One megawatt is sufficient to power about 1,000 homes.)

Alberta's EIA process, like other environmental reviews, is a process that allows for full public participation. It too includes public notification and opportunities to comment.

The steps in the regulatory process are set out in Appendix I and II of this document.

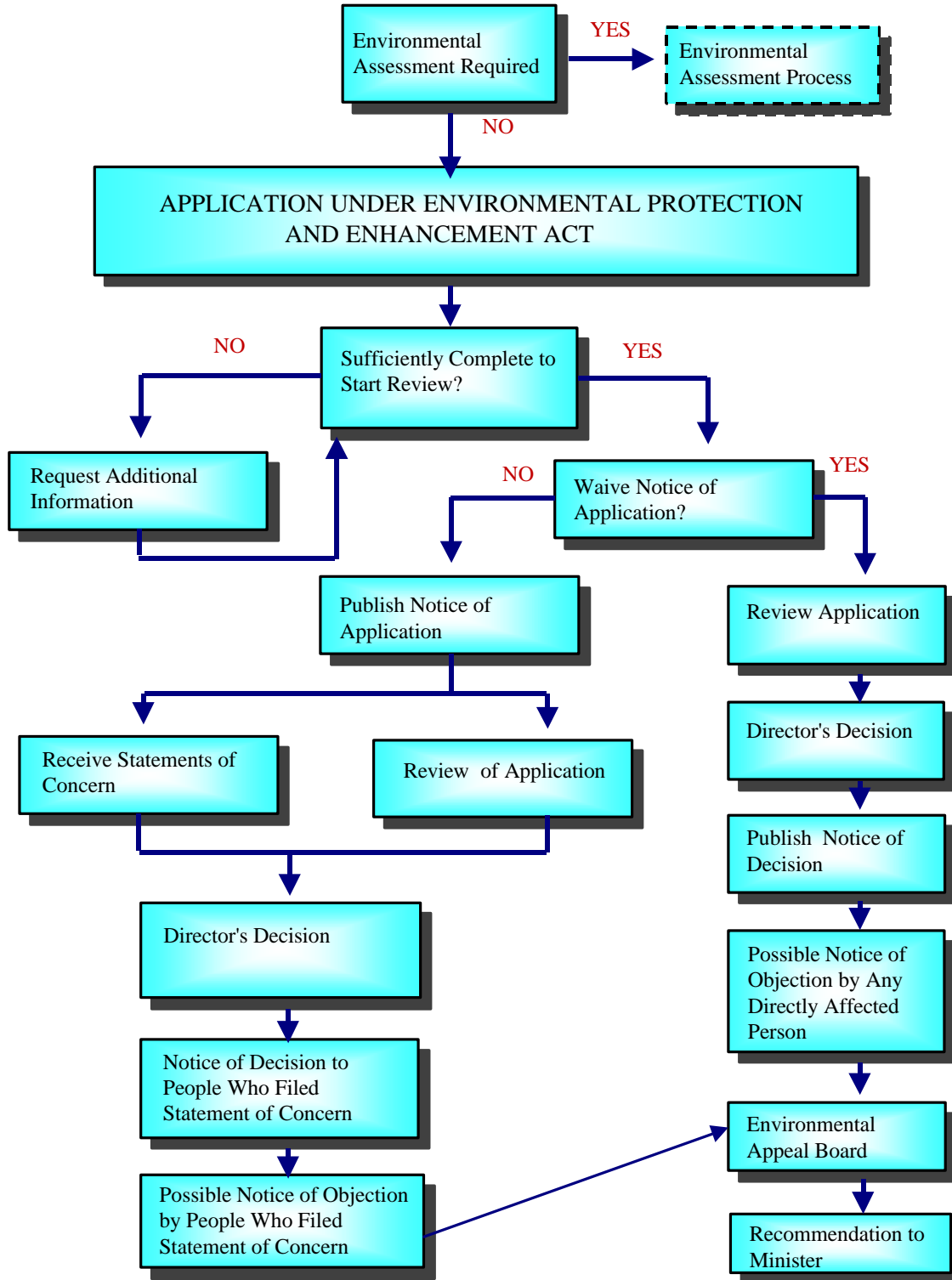

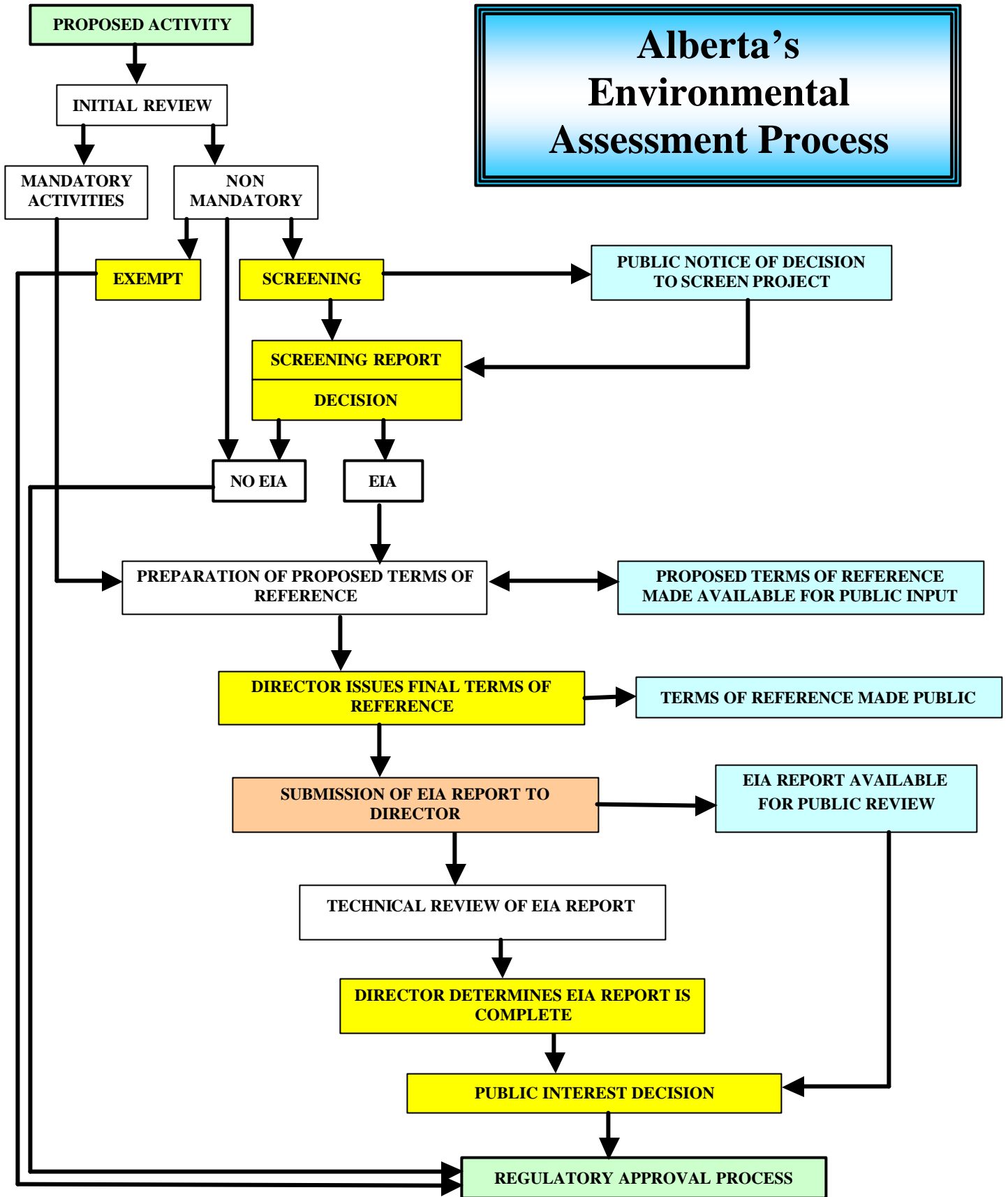
