

## Aerial Certification Class

The Recertification Program initiative for the Aerial certification class is a joint effort undertaken by the Governments of Alberta, Saskatchewan and Manitoba. Its activities are determined by the Prairie Aerial Certification Committee. The Committee is comprised of industry, educational partners and government representatives and includes representation from [Canadian Aerial Applicators Association](#), [Alberta Aerial Applicators Association](#), [Saskatchewan Aerial Applicators Association](#) and the [Manitoba Aerial Applicators Association](#). The committee has determined the following phase in for the Aerial class **in Alberta To obtain the phase in period for the Saskatchewan or Manitoba Aerial applicators, please contact the Saskatchewan or Manitoba regulatory officials (see above for phone numbers):**

- Applicators with certificates expiring in 2004 will renew by rewriting the certification exam or obtaining 5 continuing education credits. The 5-credit option will only be available until December 31, 2004 after which 10 credits will be required.
- Applicators with certificates expiring in 2005 will renew by rewriting the certification exam or obtaining 10 continuing education credits. The 10-credit option will only be available until December 31, 2005 after which 15 credits will be required.
- Applicators with certificates expiring in 2006 will renew by rewriting the certification exam or obtaining 15 continuing education credits.

Courses/Sessions approved for continuing education credit are listed below.

### Aerial - Sessions Approved for Continuing Education Credit

#### NOTE:

- **STANDARDIZED SESSIONS (SESSIONS WHERE THE COURSE CONTENT DOES NOT CHANGE) CAN ONLY BE TAKEN ONCE FOR CREDIT IN A CERTIFICATION PERIOD. For example, the NAIT IPM Fundamentals Course can only be taken once for credit in an applicator's certification period.**
- **ONLY ONE OF THE SESSIONS THAT ARE BASED ON THE LAKELAND COLLEGE HOMESTUDY COURSE (YELLOW SHADED SESSIONS IN THE TABLE BELOW) CAN BE TAKEN FOR CREDIT IN A CERTIFICATION PERIOD. For example, if an applicator takes the first day of an applicator tutorial, they can not get additional credits for taking the Authorized Assistant or Olds College Core Review Session as they are all based on the Lakeland College homestudy course.**
