Agriculture Certification Class

The Recertification Program initiative for the Agriculture certification class has been determined by the Agriculture Certification Committee. The Committee is comprised of industry and government representatives including representation from the Certified Crop Advisors and the Canadian Association of Ag-Retailers. For more information on pesticide recertification, call 780-538-8054. The Committee has determined the following phase in for the Agriculture class:

- Applicators with certificates expiring in 2004 will renew by reapplying for their certificate. This option will only be offered until December 31, 2004 after which 5 credits will be required.
- Applicators with certificates expiring in 2005 will renew by rewriting the certification exam or obtaining 5 continuing education credits. The 5-credit option will only be offered until December 31, 2005 after which 10 credits will be required.
- Applicators with certificates expiring in 2006 will renew by rewriting the certification exam or obtaining 10 continuing education credits. The 10-credit option will only be offered until December 31, 2006 after which 15 credits will be required.
- Applicators with certificates expiring in 2007 will renew by rewriting the certification exam or obtaining 15 continuing education credits.

Courses/sessions approved for continuing education credits are listed below:

Agriculture - Sessions Approved for Continuing Education Credit NOTE:

- STANDARDIZED SESSIONS (SESSIONS WHERE THE COURSE CONTENT DOES NOT CHANGE) CAN ONLY BE TAKEN ONCE FOR CREDIT IN A CERTIFICATION PERIOD. For example, the NAIT IPM Fundamentals Course can only be taken once for credit in an applicator's certification period.
- ONLY ONE OF THE SESSIONS THAT ARE BASED ON THE LAKELAND COLLEGE HOMESTUDY COURSE (YELLOW SHADED SESSIONS IN THE TABLE BELOW) CAN BE TAKEN FOR CREDIT IN A CERTIFICATION PERIOD. For example, if an applicator takes the first day of an applicator tutorial, they can not get additional credits for taking the Authorized Assistant or Olds College Core Review Session as they are all based on the Lakeland College homestudy course.
