

For the 2006-2007 Rebate Year

- Agriculture irrigators, commercial greenhouses, forage dehydrators and grain dryers who use natural gas, propane, heating oil and kerosene are eligible to apply for a rebate and can choose a maximum of six months in each rebate year.
- Applications can be made at any time before the June 30, 2007 deadline.
- Agriculture natural gas consumers who would prefer rebates for the October to March winter heating period may be able to receive their rebate on their natural gas bill. Contact the Program Office for more information.
- All Agriculture rebates will be paid by government cheque. Rebate cheques will be held for all agriculture consumers until the rebate value reaches \$25.
- A separate application is required for each gas meter or fuel tank and for each rebate year.
