Groups Can Remit Premiums for Senior's Alberta Health Care Insurance Plan (AHCIP) Accounts

Why seniors need to be treated differently from the other employees on your group plan

Albertans who are 65 years of age and older, must also pay basic health premiums.

Seniors and their spouse/adult interdependent partner/ dependants receive premium- free Alberta Blue Cross coverage once proof of age is received. AHCIP premiums must be remitted separately if either the employee or their spouse/partner is a senior. This will ensure that the employee and any dependants continue to receive premium-free Alberta Blue Cross coverage.

How to remit premiums for seniors

You can remit seniors' premiums as follows:

- Complete a *Group Payment Listing for Seniors Premium Remittance* (AHC1086). You can copy this form as you need it, download it from our website at www.health.gov.ab.ca, order larger quantities on-line at www.dbf.com/Mktg/acsc/index.asp or use the Forms Requisition card (AHC0144).
- Submit the AHC1086 and payment along with your regular monthly payment. If you are making your payment at a chartered bank or financial institution, please mail or fax the form to our Edmonton office at:

How the payments are applied

Alberta Health and Wellness will apply the payments you remit for these employees to their individual accounts. They will receive premium statements reflecting these payments. If they prefer not to receive premium statements while you are remitting monthly premiums on their behalf, please notify our office.

It is important that you complete and forward an *Employee Group Commencement and Termination* (AHC0199) to Alberta Health and Wellness, when these employees terminate from your group plan. This will ensure they will receive a premium statement directly from Alberta Health and Wellness after they terminate from your group plan.

Premiums Rates

Seniors are required to pay the same AHCIP premiums as your other employees, unless they are eligible for full or partial premium exemption through the Alberta Seniors Benefit Program. Premium rates are \$44.00 per month for single employees and \$88.00 per month for employees with families. Alberta Seniors will send seniors a notice if their premium rate changes. You should remind your employees to advise you if this happens.

As with your other group members, any cost sharing arrangements for premiums are between you and the individual(s) involved.
