Assessment Alberta Health and Wellness conducted its due diligence in reviewing the Summary: proposals as per *Health Care Protection Act* (HCPA) according to the *Established Ministry Criteria for HCPA Agreements*. The proposals meet the criteria in all respects and responds effectively to the region's responsibility for ensuring timely access to Ophthalmology, Plastic Surgery, Dermatology, and Pregnancy Termination surgical services.

I reviewed the proposals taking into consideration the department's recommendations, and adherence to provincial and federal legislation.

Compliance: Since September 28, 2000, the provision of surgical services by private facilities must comply with the HCPA. I am satisfied that the proposals meet those requirements, provide a public benefit and show no adverse impact on our public health system, or our ability to comply with the *Canada Health Act*.

The Non-hospital Surgical Facilities referenced in the proposals from the Capital Health Authority have a sufficient number of qualified and appropriately trained staff to manage the volume of work. There is no negative impact on the health workforce available to serve the needs of the Capital Health Authority. The physicians on staff in these facilities have proven qualifications and experience in the provision of these surgical services. Mechanisms are in place to monitor physicians' compliance with the *Medical Professions Act*.
