WRITING-ON-STONE PROVINCIAL PARK

All those parcels or tracts of land, situate, lying and being in the first (1) township, in the thirteenth (13) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

- (A) Sections twenty-four (24), twenty-five (25) and twenty-six (26), the north half of section thirteen (13), the north west quarter of section fourteen (14), the west half of section twenty-three (23), legal subdivisions fifteen (15) and sixteen (16) of section twenty-seven (27), legal subdivisions one (1), two (2), seven (7), ten (10) and fifteen (15) of section thirty-four (34), all those portions of sections thirty-five (35) and thirty-six (36) and legal subdivisions eight (8) and nine (9) of the said section thirty-four (34) which lie on both sides of the Milk River, all that portion of legal subdivision sixteen (16) of the said section thirty-four (34) which lies to the south and west of the right bank of the said Milk River and all that portion of the north east quarter of section fifteen (15) of the said township lying generally to the south and east of the southeasterly limit of an unsurveyed roadway, as shown upon a plan on file in the Department of Tourism, Parks and Recreation at Edmonton as No. 1680 TEMP., containing one thousand seven hundred fifty-six and seven hundred eighteen thousandths (1,756.718) hectares (4,340.79 acres), more or less.

SAVING AND EXCEPTING:

- (1) Four and five hundred twelve thousandths (4.512) hectares (11.15 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Calgary for the South Alberta Land Registration District as No. 851 B.M.
- (2) Thirty-four and three hundred thirty-nine thousandths (34.339) hectares (34.85) acres, more or less, being more particularly described as follows:

The most northerly three hundred sixty-five and seventy-six hundredths (365.76) metres (1200.00 feet) throughout the north half of the said section thirty-five (35) which lies to the east of the most westerly five hundred forty-eight and sixty-four hundredths (548.64) metres (1800.00 feet) throughout the said section and to the west of the most easterly one hundred twenty-one and ninety-two hundredths (121.92) metres (400.00 feet) throughout the said section.

- (B) All that portion of the statutory road allowance adjoining the east boundary of the north east quarter of the said section thirty-five (35) of the said township, lying to the north of the left bank of the said river, containing one and four hundred ninety-seven thousandths (1.497) hectares (3.70 acres), more or less.

The lands herein described contain one thousand seven hundred seventeen and eight hundred sixty-seven thousandths (1,717.867) hectares (4,244.79 acres), more or less.
