- <sup>5</sup> The Alberta Local Authorities Pension Plan Corporation was incorporated during 2005-06 in the Ministry of Finance.
- <sup>6</sup> The Alberta Science and Research Authority remains an incorporated provincial agency. Its responsibilities and budgets have been transferred to the Department of Innovation and Science, Alberta Research Council Inc. and iCORE Inc. pursuant to Order in Council 103/2005. It is not considered to be an entity for budget purposes.
