This return together with a separate schedule for each fuel type must be completed and submitted with payment for taxes due to: TAX AND REVENUE ADMINISTRATION, 9811 109 ST, EDMONTON AB T5K 2L5. A tax return MUST be completed by the licensed IFTA carrier even if no operations were conducted during the reporting quarter. The tax return must be signed in the Certification area to be considered complete and it must be received by our office no later than the last day of the the month following the quarter being reported. INSTRUCTIONS

- A completed tax return and schedule(s) must be received by the last day of the month following the guarter being reported. The return, schedule(s) and payment of any tax owing must be submitted to: Tax and Revenue Administration, 9811 109 ST, EDMONTON AB T5K 2L5.
- If a return is not filed on time, a penalty will be assessed. The Late Filing Penalty is the greater of \$50 or 10% of field 40 after the return has been assessed. When completing the return, you may estimate this calculation, however, field 44 is not mandatory and Tax and Revenue Administration will calculate this field for you if it is applicable.
- For your convenience, you may fax your return and schedule(s) to (780) 427-0348. Please ensure to fax both pages 1 and 2 of all forms. If filing by fax, DO NOT also mail or deliver the originals to Tax and Revenue Administration. Payment of actual amount of tax owing, if applicable, must be received by Tax and Revenue Administration by the due date or interest will be charged from the due date until the payment is received.
- Tax returns must be submitted even if no operations were conducted during the reporting quarter.
- All fuel purchases and travel must be reported, even if operations were only in Alberta.
- Internet forms do not contain a Remittance Advice because of the need for special encoded paper required for processing at Financial Institutions. When filing using forms printed from the Internet, payment must be mailed or delivered to Tax and Revenue Administration (TRA) at the address indicated above. If an original Remittance Advice form (AT9) is obtained from TRA, then payment may be made at a Financial Institution. All payments should be in CANADIAN FUNDS and all cheques made PAYABLE TO THE MINISTER OF FINANCE. Internet payment can also be made via payment services provided by most Financial Instituions in Canada. Please contact TRA or your bank for further details.
- To reduce processing costs, Tax and Revenue Administration will normally neither collect nor refund amounts less than \$20.00. Upon specific request, Tax and Revenue Administration will refund a balance of less than \$20.00. If Tax and Revenue Administration deems it appropriate, action may be taken to collect amounts under \$20.00.
