

RETAILER REGISTRATION FOR PROPANE TAX REFUNDS

Propane retailers must register with Tax and Revenue Administration to be eligible to claim a refund of fuel tax on propane purchased tax-in but sold tax-out (i.e. cylinder fills). Retailers that will not be making any refund claims do not need to register.

A retailer can submit a separate registration for each retail outlet or can submit a "group registration" for all retail outlets under its legal control. For each registration, this completed form and the Application for Direct Deposit (form AT4812) must be submitted to:

Once the registration is approved, the retailer will get directions on how to claim tax refunds.
