The Alberta Corporate Tax Act

Taxation Year Ending:

For corporations to apply for the Alberta Political Contributions Tax Credit under the Alberta Corporate Tax Act when contributions have been made under the Election Finances and Contributions Disclosure Act to a political party, constituency association or candidate registered in Alberta. Original receipts must be retained and, if requested, made available to Tax and Revenue Administration. If the corporation has made qualifying political contributions to a registered party that has nominated a candidate or a registered candidate under the Senatorial Selection Act in respect of an election under the Senatorial Selection Act, then see Guide for instructions on how to claim this credit.

Report all monetary amounts in dollars; DO NOT include cents.
