The County's main industry is agriculture but is supplemented by oil and gas production, manufacturing and food processing. Agriculture in the County ranges from grain and specialty crops to domestic and specialty livestock. Producers mainly grow grains such as wheat,oats, barley and canola.






Two Hills No. 21, County of Population by Age Group (2001)

Two Hills No. 21, County of Highest Level of Schooling 2001














Total Gross Farm Receipts

Age of Farm Operators




