## International Organizations

## ISO/CASCO: Serving the needs of global trade

The purpose of the International Organization for Standardization (ISO) Committee on Conformity Assessment (CASCO), is to:

- study means of assessing the conformity of products, processes and services to appropriate standards;
- prepare international guides and standards relating to the practice of testing, inspection and certification of these products and services; and
- promote mutual recognition and acceptance of national and regional conformity assessment systems.

CASCO has a number of Working Groups (WGs) that develop and review international guides and standards. Canada participates in 15 CASCO WGs.

#### **Activities**

The latest CASCO plenary meeting was held in Geneva on November 29-30, 2001. The Standards Council was

recognized for sponsoring the participation of two developing countries, Tunisia and Costa Rica.

At the plenary, ISO/CASCO Strategies 2002-2004, the committee's first strategic plan, was approved. The plan focuses on a number of key objectives.

#### Market relevance

CASCO has set up a Market Feedback Panel so stakeholders can provide their views on current and new conformity assessment guides and standards. You can provide feedback to this panel through the ISO Web site.

#### Leadership

To increase the participation of developing countries, a joint DEVCO (Committee on Developing Country Matters) -CASCO Group on Conformity Assessment Strategies will be established. Its main project will be the development of an interactive Web site to involve more developing countries in the process of reviewing CASCO documents.

## **CASCO Communications**

The CASCO Communications Group will continue to organize public workshops, and improve the delivery of CASCO's services through the Web.

#### **Optimization**

CASCO is seeking more balanced representation of stakeholder groups. Over the coming year, the

committee will develop a framework to address this issue.

## WTO/TBT meeting: On-going consultations

The World Trade Organization (WTO) Technical Barriers to Trade (TBT) Committee met on October 8-9, 2001. David Shortall, Manager, Intergovernmental Affairs and Trade represented the Standards Council at these meetings.

Formal and informal consultations focused on:

### Labelling

The European Commission (EC) proposed to seek clarification of TBT rules with respect to labelling. Canada and several other countries favour more informal structured discussions on this complex issue.

# <u>Trade-related Technical Assistance for</u> <u>Developing Countries</u>

A questionnaire is being developed to evaluate the needs of developing countries and to determine how the WTO can assist in maximizing participation in the global trading system. The questionnaire will be tabled for approval at the March 2002 meeting.

The International Accreditation Forum, Inc. (IAF) held its Executive Committee (EC) meeting in Mexico on February 14-15, 2002. Elva Nilsen, Director, IGAT and a member of the EC attended this meeting. Agenda items included:

- progress on IAF QMS Re-Evaluations, and implementation of the EMS and Product MLA's;
- promoting the benefits and value of the multilateral recognition arrangement (MLA) to industry, regulators, certification bodies and government;
- incorporating sector schemes into the MLA;
- renewal of the IAF Memorandum of Understanding with United Nations Industrial Development Organization (UNIDO), and the International Organization for Standardization (ISO);

- survey results acceptance of ISO 9000 and ISO 14000 Certificates: and.
- establishment of an IAF Code of Conduct for Accreditation Bodies.

The next IAF Executive Committee meeting will be held on May 23-24, 2002 in Vancouver, in parallel with the International Laboratory Accreditation Cooperation (ILAC) EC meeting. The Standards Council is hosting these meetings.

## Canadian Advisory Committee on Developing Country Matters (CAC/DEVCO)

CAC/DEVCO provides advice to SCC's ACT regarding technical assistance and strategies to engage developing countries in international standardization. The committee also represents Canada at ISO/DEVCO.

#### **Activities**

Key items discussed at the February 8, 2002 meeting included:

- reviewing proposals for technical assistance projects; and,
- reviewing and providing comments on the WTO/TBT questionnaire of developing country needs (see page 2).

## Provincial-Territorial Advisory Committee (PTAC)

PTAC provides advice to the Standards Council from the perspective of provincial and territorial governments.

#### **Activities**

Key items discussed at PTAC's November 22-23, 2001 meeting included:

- Discussions with DFAIT on PTAC recommendations related to provincial and territorial involvement in the
- negotiation of government-to-government mutual recognition agreements (MRAs). The meeting provided insight into DFAIT's current approach to MRA's and thoughts of future activities and challenges.
- The establishment of National Forum on Public Safety, a forum for coordination and advice on policy and performance matters for the national public safety system.

## Coming Soon: A Guide to Consumer Product Safety Legislation

Consumer product safety legislation in Canada can be complex and sometimes confusing. Some products are subject to federal regulation, some to provincial legislation, and some to both.

Consumer Product Safety Legislation in Canada: An Introductory Guide outlines who regulates which aspects of product safety in Canada. It provides a complete list of federal and provincial legislation, along with information on the ministries, departments and agencies responsible for it. The guide will be useful to consumers, businesses and regulators.

## New Sustainable Forest Management Requirements

Sustainable forest management SFM) standards have been given a boost by the forestry industry. The Forest Products Association of Canada (FPAC) announced in January that all member companies will be required to submit their forest management practices to the scrutiny of independent third party audits, and that successful certification will be a condition of association membership in the future. One of the standards to which member companies may choose to be registered, by a Standards Council accredited EMS registration body, is the National Standard of Canada for SFM developed by the Canadian Standards Association (CSA Z809 – SFM System).


