Information Letter Statement of Account Surface/Subsurface Land and the Application of Interest

Indian Oil and Gas Canada (IOGC) is responsible for ensuring revenues are received on behalf of First Nations in a timely manner. Starting in May 2006, IOGC will be providing companies with a "Statement of Account" for Surface and Subsurface Land agreements. The initial statement will show all outstanding amounts up to and including April 30, 2006.

Interest will be calculated on outstanding amounts starting with the April 2006 period, therefore amounts due prior to April 1, 2006 will be charged interest only for the month of May 2006 on the initial statement. Manual billing covers prior time periods where the amount was outstanding. Interest on outstanding Land amounts will be calculated on the premise that if the payment is late but paid in the current month, interest will be charged from the due date to the date the payment is received. If payment is not received in the current month, interest will be calculated to the end of the following month. If payment is made prior to the end of that month, no additional interest will be charged.

Example #1 - No Payment Received - Due Current Month

Payment Date	May 15, 2006
Interest Calculation Dates	April 8-30, 2006 May 1-31, 2006
Interest Calculation on Next Statement	No Additional Interest Adjustments
