Resolution No. 4

Whereas the need for affordable housing for Aboriginal families is in crisis proportion across Canada's urban centers and in the rural communities; and

Whereas the Government of Canada has introduced a one time funding of \$300 Million dollars for urban and rural Aboriginal housing and an additional \$300 Million for territorial Aboriginal housing; and

Whereas these funds are only a small portion of the funds required to meet the need of the Aboriginal community, as defined by the National Aboriginal Housing Strategy;

THEREFORE BE IT RESOLVED THAT

NAHA develop and advance a national framework for the delivery for the Aboriginal designated funds; and further,

That NAHA pursue funding to prepare a major study to reflect the capacity and state of preparedness for Aboriginal housing corporations to act on this major housing initiative in order to build federal/provincial/territory confidence in our ability to deliver housing starts, and further

That NAHA pursue funding to host an Aboriginal housing summit in September or October 2006, inviting Aboriginal housing stakeholders and all NGOs to finalize the delivery framework and institutions.

Whereas single women families make up a significant proportion of the tenant population in Aboriginal housing corporations across Canada; and

Whereas the NWAC has mounted a major campaign, referred to as Sisters In Spirit (SIS), to draw attention to the violence and murder of Aboriginal women;

THEREFORE BE IT RESOLVED THAT

NAHA commit to meeting NWAC to determine how best Aboriginal housing corporations can play a role in providing public education among its tenant population of the dangers of violence on the street and in the home and introduce appropriate housing and community safety measures; and further,

That NAHA write to the Prime Minister supporting the SIS campaign, committing to a role in advancing the campaign and requesting government to offer greater support to curb the atrocities of violence and murder of Aboriginal women.

Resolution No. 6

Whereas this assembly, which includes international housing specialists, has been convened by the National Aboriginal Housing Association (NAHA) in Canada; and

Whereas the indigenous delegates from Guatemala request a suitable expression of support from this assembly for transmission to those in a position to call for the World Urban Forum to recommend intervention by the UN as a matter of urgency; and

Whereas the Guatelmalan delegates express grave concern over the inability and indifference of the Guatemalan government to provide housing for indigenous people in their communities, especially those who still suffer from the disaster caused by the storm known as "Stan" last year (2005) and who are still waiting for help, which the indigenous delegates from Guatemala describe as a severe concern;

THEREFORE BE IT RESOLVED THAT

NAHA take immediate steps to ensure that an appropriate expression of concern be made through and by those attending the World Urban Forum III about the concerns of the Guatemalan people and to recommend intervention by the UN as requested.

Resolution No. 7

Whereas this assembly of international Aboriginal housing specialists has been convened by the National Aboriginal Housing Association (NAHA) Canada; and

Whereas NAHA has been asked by the Aboriginal Housing providers of Redfern, in the State of New South Wales, Australia, attending this assembly, to support the Aboriginal housing companies to provide 62 family homes for Aboriginal key workers on land known as the "Block" at Redfern in the State of New South Wales, Australia; and

Whereas this assembly expresses deep concern over the New South Wales State Government's actions to discriminate against the Aboriginal Housing Company in favour of benefits for private developers, and wishes to censure the New South Wales Planning Minister for his comments about Aboriginal families' inability to manage home ownership and their inevitable descent into welfare dependency;

THEREFORE BE IT RESOLVED THAT

NAHA take all appropriate action to support the concerns expressed by the delegates from NSW, Australia and bring this matter to the attention of the Canadian government the World Urban Forum and others as may be appropriate.
