

EXPORT ORIENTATION PROGRAMS

These are a series of programs to help you learn about international markets and how to gain access to them.

These include the Export Partnering Program (EPP), targeted at new-to-exporting companies who require assistance in becoming export-ready (assistance in developing e-business strategy, web site development, promotional material, registration in the Virtual Trade Commissioner database, business skills development, and market research and strategy development).

The New Exporters to Border States (NEBS) program is a key export education tool for companies just starting out in exporting to the United States. It includes a visit to one of the Canadian Consulate and meeting with trade officers.

The Exporters to the United States (EXTUS) program is directed to companies already exporting to the U.S. and who want to expand their export business. It includes trade minimissions that last from one to three days and are often coordinated with trade shows in the U.S. to give participants a closer look at a specific sector. It provides sessions with industry experts and helps the exporter to establish networks with distributors, representatives and buyers.

New Exporters to Overseas (NEXOS), a program to introduce companies to European markets.
