According to the Gesgapegiag Health & Community Services Evaluation Report 1996-2001, the NNADAP Program is a service to be provided to different age levels in our community. (The National Native Alcohol and Drug Abuse Program.) Personally, I like to use the Awareness Program which is geared more to the ages of 8-18, especially children who are still in school and according to some community members, this would be the target group that will be the focus of this program, but not the only one.

This is what I can do for now because we have not had a NNADAP worker for a while, it will have to be started at a quarterly rate, so changes and demands can be met to the best of my ability and can be ongoing. As the saying goes, "It takes a community to raise a child," this saying can be considered the community's motto. So, I see community support is needed to get this program started and keep it going.

This is where I and other community members see how this program can help our

community (but not necessarily in this order):

- Encourage alcohol/drug free social/recreational/sports activities.
- Awareness of dangers associated with alcohol, drugs and solvent abuse videos or workshops can be provided where and when needed.
- Counseling sessions at office, home or school can be provided.
- Assist a community member that needs professional care such as rehabilitation for their chemical abuse.
- Awareness program such as FASD for pregnant mothers.
- Programs to increase better selfesteem for a more productive life: after school program (Youth Group has already been started)
- Help start support groups such as Alanon, Narcotics Anonymous or Alateen. AA groups have already been established and a schedule is already available.
- Red/Black/Yellow-Ribbon Campaigns like MADD.
- Radio messages/newsletter.
- Aftercare for those who go to treatment if requested.

- Provide information ie: pamphlets, videos, and books.
- Provide suicide intervention (need more training ASAP).
- "Role model" recognition.
- Networking
- Fundraising for summer Youth Group activities.

So far, and according to the Evaluation Report, this is what this program can do and is already doing for our community. The Community Health Representative or CHR will be someone I will be working with on matters such as FAE or FAS and Stop Smoking Program and more as we go along. Also, other community resources and parents will be asked to work with us in this program.

As far as I am concerned, I have been working in this field for at least ten years and have a BA in Applied Social Sciences, which is now known as Applied Human Sciences, and as of 2002, I am a Certified Addictions Counselor.
