- Qualifications to own a ship registered in Canada are set out in the interpretation section of the *Canada Shipping Act.* Declarations must be made before a Registrar, Justice of the Peace, Commissioner for Oaths, Consular Officer or any other person authorized by law to administer oaths in the province or territory of Canada or country where the declaration is made.
- In the case of a Canadian corporation, this Declaration must be made on behalf of the corporation by an officer of the corporation authorized by company resolution or under the seal of the corporation.
- 6. In the case of a corporation that is incorporated under the laws of a country other than Canada, this Declaration must be made by the Authorized Representative, (subsection 9.4 of the Canada Shipping Act).
