




### **GETTING READY TO TALK PIPELINE**

# ENVIRONMENTAL ASSESSMENT AND REGULATORY REVIEW

THESE FUNDING SOURCES HELP COMMUNITIES PARTICIPATE IN THE ENVIRONMENTAL IMPACT ASSESSMENT AND REGULATORY REVIEW PROCESSES.

#### **Participant Funding Program**

This program is designed to help the public participate in the review of the proposed Mackenzie Gas Project. Funds are released in three phases:

- 1. To review and comment on the draft terms of reference for the Environmental Impact Statement (EIS). Funds released in June 2004;
- 2. To participate in technical conferences and provide technical analysis of EIS:
- 3. To participate in Joint Panel Review public hearings.

ELIGIBILITY: Individuals, non-profit organizations, and Aboriginal and public governments with an interest in the proposed Mackenzie Gas Project.

#### Community Capacity Development for Environmental Assessment/Regulatory Review

This prepares communities for involvement in the environmental assessment and regulatory review of the Mackenzie Gas Project.

ELIGIBILITY: Aboriginal groups from the Sahtu, Gwich'in, Deh Cho and the Inuvialuit with an interest in the project.

#### Interim Resource Management Assistance (IRMA) Program

IRMA is designed to help Aboriginal communities strengthen their ability to participate in land and resource management activities, that affect their surrounding land use areas, including regulatory processes, environmental assessments and resource management policy.

### **NEGOTIATING LAND ACCESS AND BENEFITS AGREEMENTS**

THIS FUNDING HEI PS COMMUNITIES PREPARE, NEGOTIATE AND RATIFY LAND ACCESS AND BENEFITS AGREEMENTS.

#### **Resource Pre-Development Program**

The program is designed to assist Aboriginal organizations in the negotiation of access and benefits agreements and tax-based communities who may require fee-for-service arrangements to address impacts on community infrastructure

ELIGIBILITY: Eligible applicants represent NWT communities/organizations that are directly impacted by the Mackenzie Valley Pipeline project.

# Aboriginal Human Resources Development Strategy (AHRDS)

This strategy is designed to expand the employment opportunities of Aboriginal people across Canada. It assists Aboriginal people to prepare for, find and keep jobs. There are currently 79 Aboriginal Human Resources Development Agreement (AHRDA) holders in place across Canada.

# Aboriginal Skills and Employment Partnership (ASEP) Program

This program funds partnerships which enable Aboriginal people to acquire the skills needed to participate in economic opportunities such as oil and gas activities/projects.

#### Advanced Training Initiatives for the Oil and Gas Industry

The GNWT's Department of Education, Culture and Employment supports training initiatives to help northern workers get the required skill training for entry level employment and advancement in the oil and gas industry.

### **BUSINESS DEVELOPMENT**

ESTABLISHED FUNDING PROGRAMS THAT HELP ELIGIBLE COMMUNITIES AND BUSINESSES UNDERTAKE RESEARCH AND PLANNING, BUSINESS START-UP AND EXPANSION AND ECONOMIC INFRASTRUCTURE INITIATIVES. FUNDS UNDER THESE PROGRAMS CAN BE APPLIED TO THE PROPOSED MACKENZIE GAS PROJECT.

#### **Aboriginal Business Canada**

This Industry Canada program provides financial assistance, information, resource materials and referrals to support Aboriginal entrepreneurs in a range of business activities. Business opportunities linked to pipeline construction in northern Canada may be eligible for support. Applicants must demonstrate that the business or project would: derive more than 60 per cent of its revenues from pipeline construction activities; or, receive more than 60 per cent of the value of its inputs from pipeline construction activities. Each proposal is assessed on its own viability and merits, and takes into account the need, the scope of the project, and other possible sources of financing. #### **DIAND BUSINESS DEVELOPMENT PROGRAMS:**

#### **Community Economic Development Program**

Funding is provided to communities to develop community economic development plans. Areas of development can include (but are not limited to): plan resource or development projects, provide job-related training, and management of financial and technical services.

#### **Resource Partnership Program**

This program co-funds activities leading to the creation of a joint working agreement. The goal is to obtain economic benefits from major regional resource development projects for First Nations and Inuit communities.



#### **Major Business Projects Program**

This program provides financial assistance to eligible First Nations and Inuit businesses via their respective Community Economic Development Organization. Funding is used to obtain conventional debt financing for business start-ups or a business expansion in order to pursue a major industrial, commercial or resource-based opportunity.

#### **Opportunity Fund**

This fund provides financial aid in the form of matching equity funding. The objective is to use the funding to obtain conventional debt financing for business start-ups or a business expansion.

#### **Resource Acquisition Initiative**

This initiative helps communities to fund resource-sector and related business opportunities which may include acquiring natural resource permits and licences.

#### **Regional Partnership Fund**

This fund promotes First Nations and Inuit participation in, and expanded economic benefits from, major regional development initiatives by providing financial assistance for economic infrastructure.

## GOVERNMENT OF THE NWT BUSINESS DEVELOPMENT PROGRAMS:

#### **NWT Business Credit Corporation**

This agency provides loans and guarantees loans to business enterprises, guarantees loans made by financial institutions to business, and provides bonds to resident business enterprises.

#### **NWT Development Corporation**

The NWT Development Corporation can make minority equity investments in Northern businesses, and operates a number of subsidiaries where alternate employment opportunities are limited.

#### **Community Futures Development Corporations**

Community Futures Development Corporations (CFDCs) are regional agencies that provide loans of up to \$125,000 to local businesses. CFDCs also provide mentoring and related business assistance including training and information in support of business development.

#### **Business Development Fund**

The Business Development Fund (BDF) is a contribution fund that provides funding to individual entrepreneurs and small businesses aimed at stimulating employment and economic development throughout the Northwest Territories. The BDF has eight schedules that are designed to assist businesses during all phases of the business cycle.

ELIGIBILITY: NWT entrepreneurs and businesses (criteria varies by program).
