Dear Mrs. Girard:

I refer to your application of January 30, 2004, submitted by the Ontario Telecommunication Association ("OTA") on behalf of its members (listed below), for spectrum licences authorizing the provision of Personal Communications Services (PCS).

As you are aware, the Department, following a 1995 comparative review process, awarded, among other licences, paired "D" block (5 MHz + 5 MHz) spectrum licences, in the 1.9 GHz frequency band. As the result of this process, unassigned D Block PCS spectrum remained in certain geographical areas.

Earlier this year, the OTA members filed applications for this spectrum in their telephone service areas. I am pleased to provide the OTA members identified in your application with our approval in principle for the above noted request. Final approval of your request is subject to each OTA member providing the Department with the necessary ownership and control documentation.

Upon determining that the ownership and control documentation demonstrates compliance with the Canadian ownership and control rules, the Department will issue licences to the OTA members for the PCS "D" block spectrum in their telephone service areas.

The licences will be subject to the fees outlined in Gazette Notice No. DGRB-005-03 - Radio Authorization Fees for Wireless Telecommunication Systems that Operate in the Radio Frequency Bands 824.040 MHz to 848.970 MHz, 869.040 MHz to 893.970 MHz or 1850 MHz to 1990 MHz.
